Section 1 - General Info

- 1. The client must be 18 years of age or older.
- 2. Fluffy Yunia has the right to refuse any commission for any reason.
- 3. The client owns the paypal account, credit card and/or bank account and are authorized to make the transaction.
- 4. The client complies, and is bound by, the following T.O.S (Terms of Service) by commission the artist (Fluffy Yunia).
- 5. Fluffy Yunia does not claim rights to any characters or other intellectual properties used in the process of creating the artwork.
- 6. *Refunds* are not permitted after the line art phase.
- 7. Fluffy Yunia as the artist, maintains all rights to the completed artwork and can therefor upload the commission publicly. Whilst the client has the right to use the artwork for non commercial purposes.
- 8. The client has the right to reupload the commission with proper credit (A link to the artist social media).

Section 2 - Service

- A. The artist Fluffy Yunia has the right to refuse service for any reason. The reason does not have to be disclosed and can be kept private.
- B. I will give updates throughout the process. Please do not ask for updates on a commission as frequently as every day.

C. I will draw anything as long as its not on my do not draw list.

Though I still maintain the right to still refuse it even if its not on there. For whatever reason. (99% of times I will be accepting it)

D. The client must have a clear reference with minimal to no shading.

Section 3 - Usage

- **A.** Do not claim Fluffy Yunia's art as your own. You can edit any commission you get from Fluffy Yunia.
- B. The client does not have commercial rights to the artwork. They, the client, can not use the commission for profit. If you want to, speak to me on gaining the rights.
- C. Artwork can be reposted anywhere as long as there is credit. Not just the artist name but as well as a link to the artist social media.

Section 4 - Payment

- A. No refunds once I start the line art phase. Work only be refunded if I am unable to complete the artwork under any circumstances.
- B. At Least half of the payment must be made before the artist starts on the artwork.
- C. Chargebacks and/or non-consensual refunds are not permitted and may result in being blacklisted.
- D. If the you the client wants the artwork done quicker. You must pay an extra fee. The fee will change depending how quick you want it.
- E. Payment can be discussed. Like if the client cant pay the other half because it was eaten by bills. Fluffy Yunia the artist can discuss how we want to go further on a per client basis.

Section 5 - Commission Process

- A. The client will get unlimited small revisions to commissions. With two free major revisions for the sketch and lining phase. Major revisions are changing sex, character, poses, etc... Small revisions is anything less then that.
- B. The client will get updates through out each stage of the commission. The sketch, line art, colour/flats, and rendering/shading.

- C. The client will get the artwork in 4000x4000 pixels or higher. Saved in a PNG format.
- D. The client contact information must be active as communication is crucial for the art process.
- E. If you payed half. I wont finish the last stage until I get the other half.
- F. Commission should not take any longer then 2 weeks (If it does, I will update you the client). On average it will take 1 week or less.
