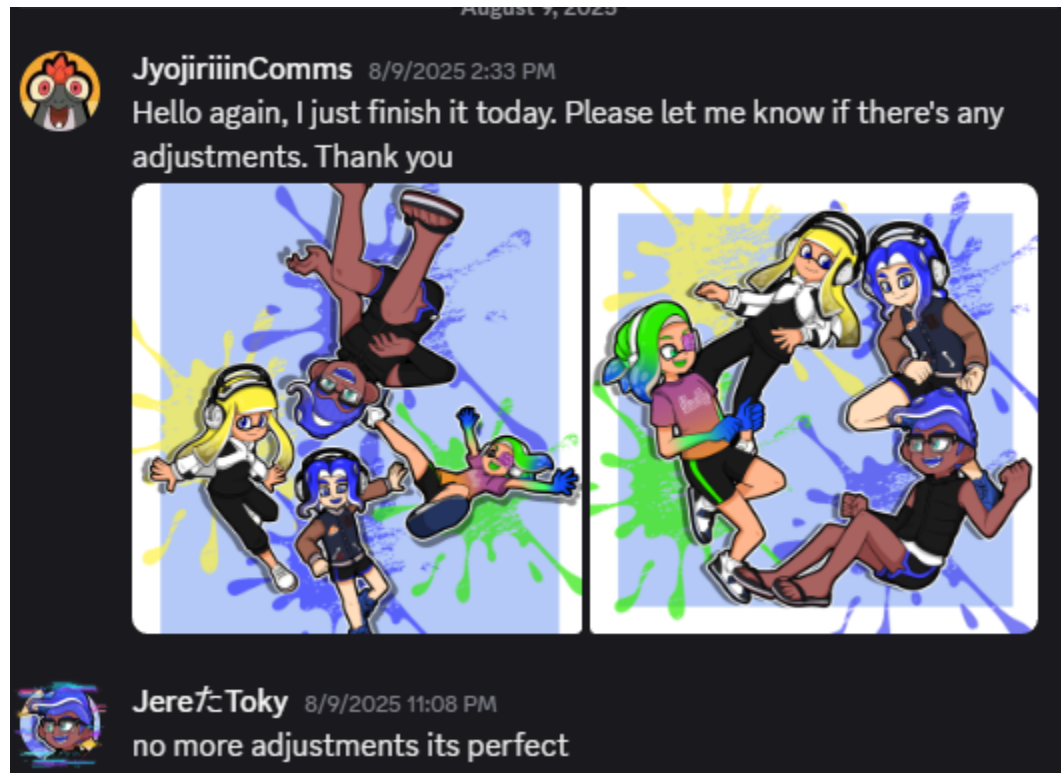

(sorry about the censors, I screenshot it so that you can see the dates)

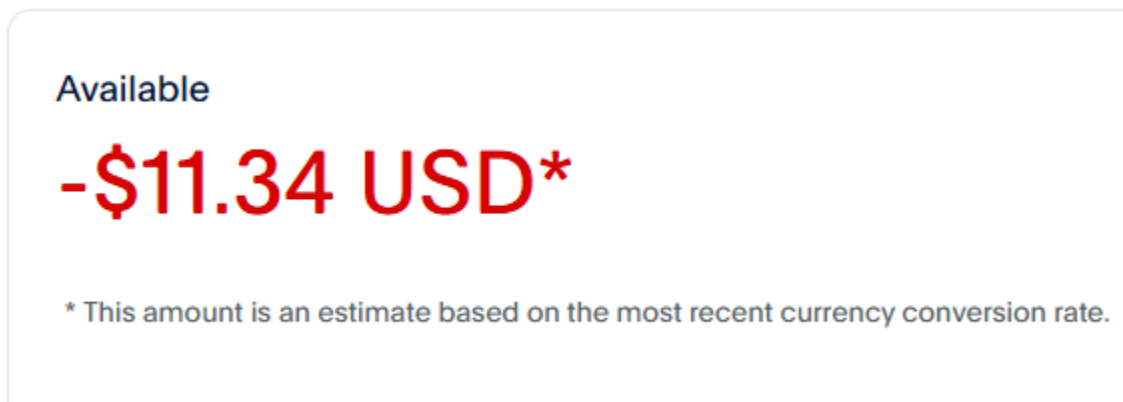


I provided all the evidence again to Paypal and it's now **under review**.

IT'S EITHER THEY USED THEIR RELATIVE'S EMAIL OR SOMEONE ELSE'S JUST TO PAY THE COMMS.

Now my funds TURNED RED because of them...uuggh!!!
I WAS GODDAMN PISSSED OFF!!



Right now, I don't know what to do. My rent and bills were due this week. I was very stressed out. Oh god...😭

So yeah, please be aware of this person if they're trying to commission you.
