On behalf of Advisory Neighborhood Commission (ANC) 4C in Washington, DC, we hereby submit this protest petition against the medical cannabis retailer license application from Mr. Tony Bullock/Bloom @ North LLC (ABCA-127912). Our protest is based on the following grounds:

The effect of the establishment on peace, order, and quiet, including the noise and litter provisions set forth in § 25-313 §§ 25-725 and 25-726: Unfortunately, Mr. Bullock/Bloom @ North LLC has demonstrated a lack of responsible management at his current establishment, allowing open consumption of alcohol and congregation outside his bar Entitlement Lounge located at 829 Upshur Street NW. This behavior violates DC regulations and negatively impacts the peace, order, and quiet of our neighborhood. We are concerned that this same disregard for regulations may extend to the operation of a medical cannabis dispensary, potentially leading to similar issues with cannabis consumption and congregation of customers outside his business which blocks the sidewalk for pedestrians and impedes foot traffic to adjacent businesses (see appendix A for photos).

In addition, Mr. Bullock does not have prior experience owning and running a cannabis business. The operation of a medical cannabis dispensary requires specialized knowledge of cannabis products, dosing, regulations as well as safety and security considerations. His lack of experience in this field, in combination with the above violations, raises concerns about his ability to responsibly and safely manage a medical cannabis retail operation and comply with the strict regulations governing such establishments.

Mr. Bullock/Bloom @ North LLC has also demonstrated a disregard for proper waste management at his current establishment Entitlement Lounge located at 829 Upshur Street NW, allowing his trash receptacles to overflow and at times disposing of waste in neighboring business' trash cans (see

appendix B for photos and records of correspondence). Trash overflow and the resulting unsightliness, public health impacts as well as issues with rodents and pests is a persistent issue in the area and we are concerned that this disregard for existing waste disposal regulations may extend to the operation of a medical cannabis dispensary under his ownership, potentially leading to escalating waste overflow and the resulting impacts.

2. An overconcentration of cultivation centers, dispensaries, or testing laboratories in the affected ward (DCMR 22-C5109):

The address that Bloom @ North is applying to open a medical cannabis retailer (827 Upshur Street NW) is directly adjacent to a preexisting cannabis business, Cannabis Karma, located at 825 Upshur Street NW. This preexisting business has been in operation since 2016 and is respected by neighbors and well-liked by customers as evidenced by the number of neighbor signatories to her own protest petition. As per new regulations, Cannabis Karma submitted their medical cannabis retailer license application (as an equity applicant) on April 24th (see appendix C) and is awaiting approval.

3. The potential adverse impact of the proposed location to the neighborhood (DCMR 22-C5109):

As stated above, we are concerned that, given the history of misuse of public space and improper trash/waste disposal at Mr. Bullock/Bloom @ North LLC's other business (Entitlement Lounge) makes us concerned that these same issues would plague any cannabis business they open, having a negative impact on the neighborhood.

In addition, the location that Bloom @ North has proposed to open (827 Upshur Street) is adjacent to Cannabis Karma, a preexisting, successful, Black women owned and run cannabis shop currently in the process of obtaining their medical cannabis retailer license. If Bloom @ North opens a medical cannabis retailer at 827 Upshur Street it may result in the forced closure of Cannabis Karma given § 7–1671.06 (q-1)(1) "No retailer license shall be issued for a facility that is located within 400 feet from another facility operating under a retailer license." As evidenced by Cannabis Karma's own protest petition, which garnered over 40 signatures from neighbors, as well as their positive reputation among customers, the fact that our Commission has never received a complaint about their business (rare for a cannabis shop in DC) and their positive engagement with community events like Art All Night and Celebrate Petworth, the forced closure of Cannabis Karma as a result of a new, inexperienced cannabis seller opening next door would be a loss to our community and the Upshur business corridor. As a Commission we are deeply invested in helping the Upshur business district to thrive and it is not beneficial to the block to see one store front open just to have another forced to close. We are not enthusiastic about the idea of swapping one empty storefront for another. We encourage Bloom @ North to explore other locations for their cannabis retailer and stand up a different classification of business at 827 Upshur Street that would add unique value to Upshur Street in the spirit of seeing the Upshur business district collectively thrive and provide a diversity of commercial options for residents of 4C and greater Petworth.

We believe these factors make the application from Mr. Bullock/Bloom @ North inappropriate for approval under the standards outlined in § 25-313 and § 7–1671.06. ANC 4C requests that ABCA carefully consider these objections when evaluating the application from Mr. Bullock/Bloom @ North for a medical cannabis retailer license at 827 Upshur Street NW.
