If accepted by the by the LLC I will be permitted to use a boat or fish from the bank on only the HL Land LLC portion of the lake. Permission will be indicated by receipt of a laminated card.

- \$95 _____ Individual: Myself and up to two guests accompanied by me.

I acknowledge that I understand where the HL Land LLC border crosses the lake on the northern tip. I agree to not cross this line unless I first obtain separate permission from the adjoining neighbor to do so. I agree to abide by all Kentucky rules and regulations.

I acknowledge I may use a canoe, a row boat, a kayak and/or a paddle boat. **I will not use a boat powered with a gasoline motor.** Electric trolling motors 5 hp or less are allowed.

I will not use a trotline, jug line or throw line.

I also agree to dispose of my trash by taking it out with me or placing it in the receptacle at the spillway properly designated for trash.

I also agree to report in a timely manner to Haley Frazier (606-748-2320) the presence of persons fishing at the lake who do not have authorization for access. I will attempt to identify or obtain a description of such persons as well as a description of their vehicle and its license number.

I hereby affirm that I and any members of my family and guests are aware of the dangers of water sports and have the requisite skill and knowledge to fish, boat and use the lake safely and wisely.

I hereby acknowledge that I, my family members and guests, forever release and will hold HL Land Holdings LLC and its members and managers harmless from and indemnify HL Land Holdings LLC and its members and managers against any claims of liability should adverse events occur while on the property and/or while using the lake.
