Meeting was called to order at 10:03am.

Role of the Town Democratic Committee

The committee discussed its role and how to be effective since there is a lot going on. It was agreed that the Town Committee's primary purpose is to focus on getting Dems elected, getting the Democratic platform advanced and improved, and promoting participation in local democracy, esp. local elections. Related issues that the committee felt were important for it to

promote included getting legislation passed that expands state government transparency and in particular supporting an audit of the legislature. The committee agreed that it can best advance local advocacy on a range of other important issues by sharing information and activities from other advocacy groups in the region.

Matteo pointed out that when and if the committee posts announcements to NextDoor Shutesbury, it should turn comments off.

In regards to communicating with State Rep. Saunders it was agreed that there is a preference to talk to him in person rather than email. In particular, to follow-up on the letter regarding Medicare for All, it was agreed that a group from the committee would go to the next office hours to speak with him directly. Part of the discussion should include asking about his reservations are so we understand and can respond accordingly since we have relevant data. Penny, Gail and Matteo will try to attend.

Activities

Penny suggested that for those who cannot go to Boston on April 5, a local Stand Out occur on the Shutesbury Common from 12-2pm. The Police will be notified for courtesy sake. Gail offered to help make signs for anyone who can get her a stick. The committee will do outreach to the email list, via NextDoor, and to neighboring town committees. There was discussion about reaching out to the local news outlets to promote the concept that grassroots matter and showing up throughout western Mass. shows peoples' commitment.

- Immigration Legal Defense Act S1127, H1954 all in committee
