

Resizer – Privacy Policy

Resizer values your privacy and is committed to protecting your personal information. This Privacy Policy explains what data we collect, how it is used, and your rights as a user.

1. Intended Users

Resizer is designed for users aged **13 and older**, including photographers, editors, and general users who wish to resize, compress, or manage images. The app is **not intended for children under 13**.

2. Information We Collect

Resizer does **not collect, store, or transmit** any personal or sensitive user data.

The app may generate a **log file** (e.g., for debugging or support), but only if **you manually enable and export it**. These logs stay on your device unless you choose to share them.

We do **not** access your identity, contacts, location, or any unrelated device data.

3. Use of Storage (All Files Access)

Resizer uses the **All Files Access permission** to save log files and image outputs to a user-defined or /Resized/Picture/ && /Resized/Logcat/ folder in your internal storage.

- The app does **not scan, collect, or upload** any unrelated files or media on your device.
 - File access is used **exclusively for processing images and saving app-generated content**, such as resized images and logs.
 - You have full control over what is saved and where.

4. Image Processing

All image resizing and compression actions happen **locally on your device**. No images are uploaded, shared, or analyzed externally.

- The app does **not transmit or store** any image or metadata.
 - You are fully in control of what gets processed and where it's saved.

5. Internet Access

Resizer uses an internet connection **only to check for app updates**.

No personal data is transmitted or collected over the internet.

No analytics, ads, or background network activity are performed.

6. Third-Party Libraries

Resizer uses secure and trusted open-source libraries (e.g., AndroidX, Material Components, Image Compressor) to improve app performance and design.

- **No advertising**, analytics, or tracking SDKs are integrated.

7. Data Sharing

Resizer does **not** share any data with third parties.

All files, logs, and images remain **local to your device**, unless you explicitly choose to export and share them.

8. Children's Privacy

While Resizer is not designed for children, it may be used by users aged **13 and above**.

We do **not knowingly collect or store personal data** from users under 13 years of age.

9. Changes to This Policy

This Privacy Policy may be updated from time to time. Changes will be posted within the app or on this page with the revised date.

11. Data Deletion

Resizer does **not collect or store any user data** on external servers.

All files generated by the app (e.g., resized images or log files) are **stored locally on your device**.

You can delete these files at any time using:

- Your device's file manager.
- Any third-party file management tool.

No data deletion request is necessary, as **no data is ever uploaded or stored by us**.
