## I. Skyla Chan | USG Treasurer

- USG Program Change
  - I'd like to earmark the funds needed to cover 2023-2024 outstanding club reimbursements. To do this, I propose we move \$20k from the USG Programming budget - Emotional, Spiritual, and Physical Events Program to the Social Events Program - Miscellaneous Line.
    - **Abibatou Diarra** | **USG Representative Senator:** How much would remain in the former budget after allocation to the latter?

- **Skyla:** Around \$11k.
- Christian Perez | USG Chair of Marketing: Do you think the \$11k would be enough to cover this semester's events?
- **Skyla:** We aren't exactly sure, it depends how many budget proposals we get.

#### USG Earmark

- Our advisors from the Office of Student Life (OSL) let us know that the

- **Dave:** Changes would be in effect by next semester. It would have to gather signatures and be voted on by the student body, similar to student government elections.
