

Privacy Policy — Chess.com Discord Rich Presence Extension

1) What this extension does

This browser/desktop extension reads your **Chess.com username** and **rating** and shows them in your Discord Rich Presence so your friends can see your chess status.

2) Data we collect

- **Chess.com username**
- **Chess.com rating** (e.g., Blitz, Rapid, etc.)

We do **not** collect your email, password, payment info, messages, or any other personal data.

3) Where the data comes from

The extension retrieves the above data from Chess.com pages you visit (or your public profile, where applicable). You control whether the extension is active.

4) How we use your data

We use your username and rating **solely** to:

- Display them in Discord Rich Presence on your profile card.

We do not use this data for analytics, advertising, profiling, or any unrelated purpose.

5) Where the data goes

- **Local processing:** Data is processed on your device.

- **Discord client:** Your username and rating are sent to the Discord client on your device to render Rich Presence. Discord's handling of presence data is governed by **Discord's** own policies.

We **do not** sell or rent your data. We do not share it with third parties, except as necessary to display Rich Presence in the Discord client.

6) Storage & retention

By default, we **do not permanently store** your username or rating on our servers. Any values are kept **in-memory** while the extension is active and are discarded when you close the app/agent.

If you enable logs locally for troubleshooting, those logs stay on **your** device and you can delete them at any time.

7) Your choices & controls

- **Disable or uninstall** the extension to stop all collection and display.
- **Clear local logs/config** (if you enabled them) to remove any locally saved data.
- **Contact us** (see above) to ask questions about this policy.

8) Legal bases (GDPR/UK GDPR, where applicable)

We process your username and rating based on:

- **Your consent** (you enable and use the extension), and/or
- **Legitimate interests** (to provide the Rich Presence functionality you requested).

You may have rights to access, correct, or delete your data; to object to or restrict processing; and to data portability. To exercise these rights, contact us (see above).

9) California privacy notice (CPRA)

We **do not sell or share** personal information as defined by the CPRA. You can request to know or delete information we hold by contacting us (see above). Because we do not maintain

server-side records by default, there is typically no retained personal information beyond what is transiently processed on your device.

10) Security

We use reasonable technical measures and local processing to reduce risk. No system is 100% secure; use strong device security and keep your software up to date.

11) Children's privacy

This extension is not intended for children under 13 (or the applicable minimum age in your region). We do not knowingly collect data from children.

12) International use

The extension may be used globally. If you use it outside your home country, your data is still processed locally on your device and by the Discord client on your device.

13) Changes to this policy

We may update this policy to reflect functionality or legal changes. We'll update the **Effective Date** above and, where required, notify you through reasonable means.
