This Privacy Policy describes Our policies and procedures regarding the collection, use, and disclosure of Your information when You use the Crazy Blast: Color Bricks Legend app and informs You about Your privacy rights and how the law protects You.

We use Your Personal Data to provide and improve the Service. By using the Service, You agree to the collection and use of information in accordance with this Privacy Policy.

Interpretation and Definitions

Interpretation

The words with initial capital letters have meanings defined under the following conditions. These definitions apply whether the terms appear in singular or plural.

Definitions

For the purposes of this Privacy Policy, the following terms shall be understood as defined below:

Account: A unique user profile established to access the Service or specific features within it.

Device: Any electronic equipment capable of connecting to the Service, including but not limited to mobile phones, tablets, and desktop computers.

Personal Data: Information that can identify an individual, either directly or indirectly.

Service: Refers to the Crazy Blast: Color Bricks Legend mobile application.

Service Provider: Any third-party organization or individual engaged by the Company to support, operate, or analyze the Service.

Usage Data: Information automatically gathered during interaction with the Service, such as session length, in-app behavior, and performance statistics.

You (or Your): The person using the Service, or a legal entity acting on behalf of such individual.

Collecting and Using Your Personal Data

Usage Data is collected automatically and may include:

Tracking Technologies and Cookies

Use of Your Personal Data

Your information may be processed and stored outside Your jurisdiction, where data protection laws may differ. By using the Service, You consent to such transfers, and We will ensure Your data is treated securely.

Deleting Your Personal Data

You may request deletion of Your Personal Data by contacting Us. Note that We may retain certain information where legally required.

Disclosure for Legal Reasons

We may disclose Your Personal Data if required by law, to protect Company rights, or to ensure user safety.
