Tick the box if the factor is present based on what the victim/survivor reports or what has been evidenced through other sources. It is assumed that your main source of information is the victim themselves. If this is not the case, please indicate in the right hand column why you have answered 'yes', particularly where the victim has stated there is no concern. Please remember that, where a question in the risk assessment doesn't have specific prompts around anti-racist practice, the issues explored are no less important for Black and global majority people. Please ensure that you ask if the person you are completing this work with has any access, support or communication needs and use approved interpreters as needed. Please make sure that you are aware of the proper language and terminologies in regards to LGBTQ+ considerations, do not assume that the client is heterosexual or not part of the LGBTQ+ community even if their partner is of the opposite sex. If the victim/survivor is 16 or 17 years old please refer to the Hackney Child Wellbeing Framework and refer to MASH@hackney.gov.uk. 16 and 17 year olds; status as children is the primary context. | • | Has the current incident resulted in injury? Have there been previous injuries? Please list current injuries and any previous injuries Agencies responding to Black people who have experienced physical abuse may have failed to ask about, overlooked or dismissed signs of bruising. When exploring injuries, ask about any injuries that are not visible Remember that abusers may explain injuries to someone with a disability as resulting not from abuse but from neglect from a carer or from an accident in the home. Also someone with a disability falling may be due to their abuser not allowing adaptations to be used or intentionally placing hazards which make the home more dangerous | Comment / Details: | | |

| • | Are you frightened? Some Black and global majority people may exhibit fear differently (eg anger, frustration) as in some cultures there is stigma attached to showing fear and disclosing abuse. This does not reduce how fearful they are. Consider that you may have to exhibit more curiosity. If a victim/survivor's child has been aggressive to them since before they were adults and this has continued for many years they may describe what is happening as 'normal'. Consider exploring specific incidents as well as home life in general to encourage them to share how they feel/felt Consider that some disabilities may mean the victim/survivor doesn't have full capacity to understand abuse or risk Those from LGBTQ+ community may have an increased sense of fear due to their sexuality being a private matter and/or if dealing with the domestic abuse alone because of isolation (see below) If the abuser is linked to a gang or is exploiting the victim/survivor financially this can increase the level of fear | Comment / Details: | | |

| • | Consider the impact of historical events where Black and global majority people were unfairly treated by those in authority and how this will affect perception of how the victim would be believed and their ability to disclose. Consider that risk may be higher due to the physical barriers of a physical disability, i.e. if the victim/survivor cannot leave the property due to being in a wheelchair, cannot protect themselves physically or engage in a safety plan due to physical impairments i.e. leaving the home, calling the police etc | | | | |

| | Those from LGBTQ+ community are at further risk of hate crime which often can result in injury. Also domestic abuse can involve threats to tell family members / partners / colleagues about their sexual orientation if it has been private If the abuser is linked to a gang or is exploiting the victim/survivor the level of violence they face if seeking help or trying to separate may be high | | | | |
| 4 | Do you feel isolated from family/friends? e.g. does [name of abuser(s)] try to stop you from seeing friends/family/doctor or others? | Comment / Details: | | | |
| • | Remember that victims may be already geographically separated from friends and family. It may be that online / phone contact is the only method available, so explore that form of wider support as well as in-person contact. Consider access to non-familial support e.g. faith and community groups. | | | | |
| | Remember people with disabilities are often already isolated and the perpetrator may further use this to abuse and control. They may rely on the abuser for getting out of the home, travelling, basic care, communicating with other people etc. LGBTQ+ victims/survivors are at increased risk of isolation due to the discrimination from friends and family and the fear that speaking out may compromise their privacy | | | | |
| • | Sexual or criminal exploitation can occur through grooming involving threats, inducements and manipulation over a considerable period of time. A feature of this is increasingly isolating the victim/survivor from family and safe friends | | | | |

| • | Victim/survivors at risk of 'Honour' Based Violence may not have expressed a request for separation with their partners and/or family members due to fear of serious harm. Immigration status can also affect someone#s willingness to attempt separation Consider if they have asked the perpetrator to leave the family home or have tried to end contact. Remember that for parents who are being harmed by their adult children it can be extremely difficult to ask them to leave the home that they may have lived in since childhood. To do so can cause a great sense of failure and betrayal on the part of the person being harmed. Explore whether the person may want to leave the abuser but feels they can't as the abuser is their formal/informal carer and/or they rely on them heavily for support Remember there may be additional barriers to LGBTQ+victims/survivors leaving the relationship out of fear of the abuser exposing their privacy. Also, if isolated, the abuser may be the only source of support regarding sexuality in the face of wider family / community discrimination Remember that for people who are linked to a gang and/or are being exploited along with others, their peer group may be intrinsically linked to their intimate partner relationship. Separating can thus involve loss or a peer group. | | | |

| • | Families can come in many forms. Consider formal and informal family relationships including guardianship arrangements and private fostering arrangements Consider grandchildren - formal or informal contact / special guardianship arrangements, whether the child's parent controls or impedes contact with grandparent Consider any child's disability; is the abuser making it difficult to manage contact and ensure the child's additional needs are met? Is the abuser accusing the victim/survivor of not meeting the care needs of a disabled child? Consider that a victim/survivor who is being exploited and/or is involved in criminality may feel inhibited from disclosing abuse because of fears it will affect their role as a parent | | | |



| • | Does [name of abuser(s)] constantly text, call, contact, follow, stalk or harass you? Please expand to identify what and whether you believe that this is done deliberately to intimidate you? Consider the context and behaviour of what is being done. Consider whether the perpetrator uses 3rd parties such as family, friends, religious or community organisations as means to apply pressure or monitor survivors Do adult children turn up at the house where they used to live when younger, insist on being let in or force entry? Remember that abusers can present as being worried for the victim/survivor and seek to use professionals to gather information on them and their welfare LGBTQ+ victims/survivors may find themselves harassed or have untrue allegations made about them in dedicated LGBTQ+ forums e.g. dating/encounter sites If the person abusing the victim/survivor is also exploiting them then persistent contact at different times of the day and night may link both to domestic abuse and organising their sexual / criminal exploitation | Comment / Details: | | |

| • | Are you pregnant or have you recently had a baby (within the last 18 months)? Research has shown that in the UK, Black women are more likely to have experienced miscarriage. Be sure to explore this issue sensitively. Also include in your consideration of this question pregnancies that ended prematurely as well as those that were successful. If miscarriage or other issues relating to childbirth is a factor, explore sensitively whether the client would like specific help in this area and signpost / refer accordingly. Consider that some Asian women may be reluctant to disclose some information to practitioners from the same cultural background (due to fear of stigma in the community) and to males. Consider the age of the victim and whether this is relevant to ask e.g. for older people If there is a significant power imbalance between the victim/survivor and the abuser, consider whether any pregnancy has been fully consented to and whether the | Comment / Details: | | |



| victim/survivor understands and has access to family planning advice. If the victim/survivor has a mental disorder impeding choice then sexual intercourse may be a criminal offence Remember LGBTQ+ victims/survivors may be in the process of beginning a family e.g. through surrogacy, IVF or adoption | | | |

| 12.Does [name of abuser(s)] try to control what you do and/or are they excessively jealous? For example: in terms of relationships; who you see; being 'policed' at home; telling you what to wear. Consider 'honour'-based violence (HBV) and specify behaviour. Consider any power imbalance / potential control due to the immigration status of the victim/survivor. Is the survivor fearful that a new relationship is likely to result in harm to herself and/or any new partner? Within some families and communities patriarchal norms can mean women may be given messages that they should not have autonomy over decision making and can experience abuse if they seek more autonomy. Also remember that women within some families may have values around gender roles that differ from your own but are nonetheless valid from her perspective. Explore what level of control / autonomy the client thinks is reasonable for themself as an individual and share concerns if controlling behaviour is a clear risk. Thinking about older people and people vulnerable with care needs who rely on the abuser for support. Consider if the perpetrator is - - controlling who they have contact with / where they go? - refusing to provide agreed care / support? - preventing them from accessing or controlling access to medication / support? - making the victim/survivor's medical conditions worse? - making parts of the house inaccessible to them | Comment / Details: | | |



| • | / not making necessary adaptations? - making communication inaccessible to them? Those from LGBTQ+ community may have an increased sense of self doubt and may feel unsure of, or ashamed about, their sexuality. Abusers may use the individual's negative sense of self to exercise control. Those from the LGBTQ+ community may see domestic abuse as a heteronormative issue and therefore do not recognise their own experiences of domestic abuse, therefore its important to emphasise and explain what coercive control is. Those from LGBTQ+ may be forced or threatened with things like conversion therapy, exorcism and corrective behaviours usually by family members. This is abusive and extremely harmful. Victims/survivors who are being exploited may experience an extremely high level of control linked to the abuser profiting | | | |

| • | Victims/survivors who are being sexually exploited by their abuser may have been forced to undergo violence integrated into sexual contact both by the abuser and with those paying the abuser e.g. being choked as a 'sex act' | | | |

| • | The term sexual abuse can be a taboo for many Black and Global majority survivors to verbalise details of abuse and can be a triggering subject. Giving examples can assist: Have they been forced to have sex when you haven't wanted to (emphasising that this is wrong and against the law in marriage as well as outside of marriage)? - threatened with exposure of images/videos? | | | |
| • | threatened with exposure of premarital sex or LGBTQ+ status? Although it isn't always considered when looking at abuse between adult family members, remember that sexual abuse including being verbally degrading or exposing someone to unwanted sexual behaviour / material - can be part of intergenerational domestic abuse | | | |
| • | If the victim/survivor has a mental disorder impeding choice then sexual intercourse may be a criminal offence, even if the victim/survivor believes they are in a consensual relationship | | | |
| • | members of the LGBTQ+ community may be less likely to recognise or disclose their non consensual sexual experiences as abuse or rape, particularly if they have consented to some activities but not all. Reassure that consent can be activity-specific and if the abuser has ignored their consent this is abusive | | | |

| • | Within some families and communities the pressure on people to remain in relationships is extreme and they face real danger if they seek to escape - particularly if any wider family members have a financial stake in the relationship being maintained. Risk from the partner can be compounded by the partner's and the victim's families. While it should not be assumed that 'Honour' Based Violence is a risk, actively explore risks regarding the wider family. Consider associates of the perpetrator; are others coming to / using the home that the victim does not feel comfortable with. Sometimes older adults and/or adults with care and support needs can be vulnerable to 'cuckooing'. Consider that those from LGBT+ may experience or be at risk of domestic abuse from family members, due to | | | |
| • | homophobia, transphobia etc. If the victim/survivor is being exploited and/or if the abuser is linked with gangs or other types of criminality there may be a range of people, known and unknown to the victim.survivor, who could do them harm if asked to by the abuser | | | |

| Remember that due to systemic racism, Black men are more likely to be criminalised. 'Being in trouble' with the police will therefore not necessarily signify heightened risks of harming others through domestic abuse. Offences relating to violence and gender should be given weight as predictive factors of future harm. Abusers who exploit their intimate partners will often have had contact with criminal justice agencies, potentially for offences not connected with domestic abuse. Remember that absence of evidence is not always evidence of absence; they may not be known to police because they have been highly successful at criminal enterprise | | | | | |
