CALL TO ACTION #3: Call on Congress to support the Block the Bombs Act

The U.S. Government is providing bombs to kill Palestinian civilians en masse and destroying entire neighborhoods.

Background:

The situation in Gaza continues to deteriorate, with reports of widespread destruction across neighborhoods in Gaza City and beyond since October 2023. Military operations have included bombing campaigns, sniper activity, <u>restrictions on food and supplies</u>, and mass displacement of civilians. International bodies and human rights organizations—including the <u>UN</u>, <u>Amnesty International</u>, and the <u>OHCHR</u>—have described these actions as meeting the legal definition of genocide under international law.

At the same time, U.S. financial and military assistance continues to play a role in the conflict, raising concerns among many Americans that taxpayer dollars are contributing both to ongoing hostilities abroad and to shortfalls in funding for domestic priorities such as healthcare, education, and infrastructure.

In response, Representative Delia Ramirez introduced the Block the Bombs Act (H.R. 3565), which now has 50 cosponsors and support from the Congressional Progressive Caucus. The bill seeks to restrict the transfer of U.S.-manufactured weapons that have been linked to military operations in Gaza.
