

## **Privacy Policy**

Cowealthy Inc. built the Cow Air Smart Fan App as a Commercial app. This SERVICE is provided by Cowealthy Inc. and is intended for use as is.

This page is used to inform visitors regarding our policies with the collection, use, and disclosure of Personal Information if anyone decided to use our Service.

If you choose to use our Service, then you agree to the collection and use of information in relation to this policy. The Personal Information that we collect is used for providing and improving the Service. We will not use or share your information with anyone except as described in this Privacy Policy.

The terms used in this Privacy Policy have the same meanings as in our Terms and Conditions, which are accessible at Cow Air Smart Fan App unless otherwise defined in this Privacy Policy.

## **Information Collection and Use**

For a better experience, while using our Service, we may require you to provide us with certain personally identifiable information, including but not limited to photos that can be uploaded by you to be used to personalize your own user profile or your organization's profile and in some cases this photo can be the picture of the content that you want to create entry on (in our case, the photo of your farm or your individual animals). The information that we request will be retained by us and used as described in this privacy policy.

Additionally, since Cowealthy Smart Fan devices can connect through Bluetooth or WiFi Technology, and because this particular app has been developed for the communication and the management of nearby or remote Cowealthy Smart Fan devices, this app needs to access the Bluetooth or the WiFi of the device that the app is being used on.

For the demonstration of the Cowealthy Smart Fan devices' location data, after the permission has been granted through an informatic dialog box on the app or on your device, at the time of defining and adding a new Cowealthy Smart Fan device to your account, your device's location data can be used to set the coordinates of one specific Cowealthy Smart Fan device. User can later inspect all location data of Cowealthy Smart Fan devices that has been set. This coordinates are stored on Cowealthy servers and database through virtual machines.

## **Log Data**

We want to inform you that whenever you use our Service, in a case of an error in the app we collect data and information on your phone called Log Data. This Log Data may include information such as your device Internet Protocol ("IP") address, device name, operating system

version, the configuration of the app when utilizing our Service, the time and date of your use of the Service, and other statistics.

Since the Cow Air Smart Fan App has been developed to give users the opportunity to communicate through and manage their Cowealthy Smart Fan devices, the data sent through these devices are being logged either to Cowealthy cloud database or a local database depending on the specific agreement made with the customer or the connection type set by the user of the app.

## **Cookies**

Cookies are files with a small amount of data that are commonly used as anonymous unique identifiers. These are sent to your browser from the websites that you visit and are stored on your device's internal memory.

The app may use their own services to collect cookies in order to authenticate your user or your organization while it can also use some third-party code and libraries that use “cookies” to collect information and improve their services. You have the option to either accept or refuse these cookies and know when a cookie is being sent to your device. If you choose to refuse our cookies, you may not be able to use some portions of this Service.
