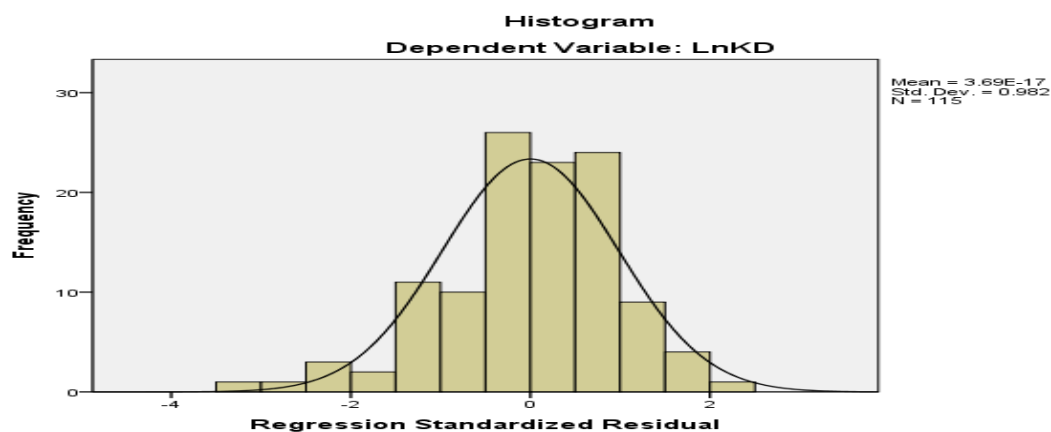

3. Manuscripts are prepared in A-4 format, with top dan left size 4 cm, bottom, and right 3 cm, 1 space. New paragraphs must start 5 characters from the left margin, using the font type Times New Roman size 12 pt.
4. The table format contains the title and content. It is enough to provide a top and bottom line, along with a line separating the title and content. The names of tables and figures follow a numbering system (Arabic). The names of the tables and figures are at the top of the tables and figures. Tables and figures provide sources of information, if any, at the bottom of both.
5. Using reference management applications such as Zotero, Mendeley, BodyNote.
6. Check Turnitin under 30 %
7. The length of the article is 3.000-8.000 words
