

## **Infant & Early Childhood Mental Health Roundtable Minutes**

**May 2026**

Greetings,

At our May Roundtable, Amy Walker CMN, MSN introduced her work as a nurse, midwife and Program Coordinator running the New Beginnings program for pregnant and postpartum patients with substance use disorder at Cooley Dickinson Hospital. She presented the **Building Stronger Beginnings** grant initiative, which includes partnerships with *It Takes a Village*, *Moms Do Care and Power*, and the *Center for Post-Traumatic Growth* to expand perinatal care for families affected by substance use disorder and perinatal mental health conditions. The program will include professional training, improved coordination between care providers, and a pilot program for patients with PTSD using a group model approach with 10 participants in the first year! FYI supports are available to non-gestational parents through both the New Beginnings program and the broader It Takes a Village initiative. *Please see the attached slides for more.*

**The success of this cross county proposal serves as a testament to the strength of our collaborations between agencies coming together to bring needed resources to Western MA. This was 1 out of 5 funded projects statewide from 35 applications! We can indeed achieve more together.**

The Collaborative shared their **free** IECMH Strong Foundations for Young Children services for families in Hampshire & Franklin Counties. There is a Chipotle fundraiser for said grant on June 6th from 4-8pm!

Andrea Gonclaves-Olviera, DMH's IECMH Statewide Policy and Initiatives Lead, shared that they will be offering a **free**, virtual floor time training that has limited spaces for each region, on 6/15,16 & 17. *Application is due by June 10.* [Details and Registration](#)

Aditi Subramanian, Director of IECMH Policy at MSPCC shared the most exciting update that a new Coalition has been delivered! **The Massachusetts Babies Coalition**, birthed from the Infant Early Childhood Mental Health Work Group formed to ensure perinatal and early childhood mental health remains prioritized in state advocacy and policy. *HUZZAH!*

The [MA Babies Coalition](#) invites each of us to join in the first inaugural Strolling Thunder MA event at the Statehouse!

This public-facing launch will center our collective 'why' for thriving babies, families and communities across MA. The event will elevate the lived experiences of families with young children (prenatal–6) who encounter gaps in our perinatal, infant, and early childhood mental health system. Modeled on successful national Strolling Thunder events led by Zero to Three, as well as similar efforts in other states, the event will bring together families with babies in strollers, coalition partners, and community organizations from across the Commonwealth.

The goal is to create an uplifting, visible moment that builds awareness and underscores the need for stronger, more connected supports for babies, families, and communities across the system of perinatal, infant and early childhood mental health (IECMH) and early relational health (ERH), ensuring families can access the relational services and supports they need to thrive.

**\* Phoebe Walker shared that Franklin County has the lowest childhood immunization rate in the whole state. Given this, and the growing likelihood of a measles outbreak, a group of local public health and medical providers are trying to get ahead and provide reliable resources and information about risks/benefits. <https://valleyvax.org/>**

**\* Phoebe also shared that the Franklin County Community Health Center has hired a new Child Psychiatrist.**

**\* We are pleased to share that there will be another round of Touchpoints training this spring in Hadley. Please share widely, especially while we are still able to offer this opportunity at a reduced rate! [May Touchpoints Info and Registration link](#)**

**\* The Cutchins Center in Northampton is expanding their space and services!**

**\*Phoebe shared this link to [the Rural Transformation Fund Project](#) where you can view the actual application that outlines the scope and narratives. The application was for 200 million, the state was granted 162 million. While the state has yet to see the funds, when they do, they will likely be coming through CommBuys in bundles for proposals as they are needing to see this all nailed down by September. Phoebe shared the attached slides to walk us through and highlight within, the initiatives where IECMH & Maternal Health would most intersect. There will be opportunities for input via advisory committees. Phoebe also shared an attached map to show how Franklin is organized by towns for assigned Public Health nurses.**

**ECHO Training on Supporting Families in Pediatrics:  
Promoting Emotional, Behavioral, and Relational Health in Young Children  
A Workshop Series for Pediatric Integrated Behavioral Health Staff**

February 18, 2026- May 27, 2026 12-1 PM (see below for dates of 8 sessions)

The Massachusetts Department of Public Health is recruiting integrated pediatric behavioral health clinicians, family partners, and community health workers and other providers throughout the state of Massachusetts to join the Supporting Families in Pediatrics ECHO Training Series. This training series aims to increase participants' knowledge, skills, and self-efficacy to integrate family engagement strategies to promote emotional, behavioral, and relational health for children under 6 years old in their practice.

Participants will engage in the ECHO model™ (Extension for Community Healthcare Outcomes) a telementoring platform that leverages video conference technology to connect experts with primary care teams in local communities, fostering an "all teach, all learn" approach.

Contact hours for nursing and CEUs for social workers, licensed mental health clinicians, and community health workers have been applied for and will be available for free. Each session will award 1 CEU/ contact hour.

This ECHO Series will utilize materials from:

- The Pyramid Model Positive Solutions for Families—An evidence-based parent skills training to foster healthy relationships and provide concrete strategies for parents to encourage their child's growth and development
- DC: 0-5—An empirical evidence-based classification system for mental health and developmental disorders for children birth to age 5 with an emphasis on relational health between the child and caregiver
- The Family Engagement Framework—A Massachusetts-based best practice resource to promote optimal accessibility for meaningful family engagement throughout child-serving systems.

- **Marisa Matsudaira, LICSW**, is the Pediatric Mental Health Access Coordinator at the MA Department of Public Health. She brings her experience as a clinical social worker leader of outpatient mental health and integrated behavioral health settings with a focus on the experience of children and their families. She is an experienced workshop facilitator for professional development, particularly addressing how systems and institutions impact families' well being.
- **Roxanne Hoke-Chandler, MS**, is the Early Childhood Systems Coordinator for Family Engagement and Training at MA Department of Public Health. ## WHAT TO SAY TO KIDS ABOUT ICE

Even if a child isn't directly affected, they may hear about ICE at school or online. Avoiding the topic can cause more fear. Calm, honest conversations help children feel safe and supported.

### START THE CONVERSATION

Begin by asking: "What do you know about ICE?" This gives you insight into what they've heard or seen. If they say "I don't know," you can gently explain:

"ICE is a government group that checks if people are following immigration laws. Some families are scared of them because they help decide who can stay in the U.S. Have you heard about people moving to new countries?"

#### AGES 3-6

"Some families are being treated unfairly because of where they were born. You're safe, and I'm here with you."

- Keep it simple and comforting
- Provide extra hugs, reassurance, and routines.

#### AGES 7-11

"Some families are being separated because of how they came to the U.S. Even kids are getting hurt, and that's not okay."

- Be honest without overwhelming

#### AGES 12-18

"It's not right for people to be treated unfairly because of where they're from. This hurts kids and families."

- Acknowledge their awareness
- Encourage healthy ways to process: writing, talking, art, advocacy.

#### EMOTIONAL SUPPORT FOR ALL AGES

"It's okay to feel scared or frustrated. What matters is we talk about it and help each other feel better."

- Encourage breathing, drawing, or journaling

#### WHAT **NOT** TO SAY

- "Don't worry about it." Dismisses their feelings
- "That won't happen to us." Creates false reassurance

#### WHAT TO SAY **INSTEAD**

"You're not alone in this. People are trying to help, and I'm one of them. If you ever feel scared, we can talk about it together."

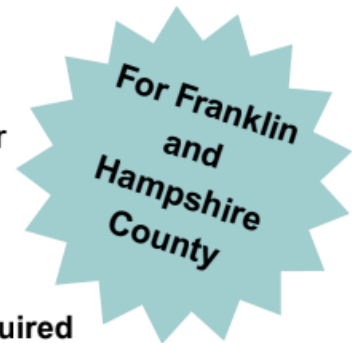

The hearing is not currently scheduled, but we are told that we could be given very short notice (as little as 48 hours) or when the hearing will be. Therefore, it is incredibly important to have testimony written and ready to share! If you cannot attend the testimony virtually or in-person, you can still submit it in written form to be reviewed by the Joint Committee on Financial Services and added to the record.

1. **State who you are in relation to this bill.**

Are you a provider of healthcare services? Are you speaking as a member having trouble accessing care? Do you work in a field that is impacted by the availability of access to healthcare?

2. **Explain why this bill matters to you.**

It is super powerful if you have a story to tell. Be brief but give enough detail to explain how clawbacks affected your ability to provide or your difficulty accessing healthcare in Massachusetts. This is so important in swaying any legislators that may be on the fence or not know how important this is to us.

3. **Ask for the members of the committee to support the bill.**

Don't forget this part! It may seem obvious, but it's always a good thing to say anyways!

## *Asking You to Support:*

### **S.770 - An Act to Prevent Inappropriate Denials by Insurers for Medically Necessary Services**

#### **WE SPEND TOO MUCH MONEY TO NOT HAVE PROPER CARE**

There is a huge amount of money spent on healthcare in Massachusetts - over 70 billion dollars. How is that possible that some people still cannot access proper healthcare? Have you ever called a healthcare provider's office to either find they don't take your insurance or they don't have any availability to see you? One of the reasons for this is that providers are becoming increasingly wary of working with insurance companies due to a practice called recoupment (commonly referred to as 'clawbacks').

#### **WHAT IS A CLAWBACK?**

A clawback is when an insurance company takes back money that it has been paid to providers for services already given and billed. Clawbacks can happen up to 12 months after the service has been completed, meaning that it can take providers totally by surprise and be well after the money has been spent on costs of the provider's practice. Each time this happens, the provider is likely to leave a network or limit the number of people that it will take with that particular insurance. Plus, they might let other colleagues know about their experience, which discourages other providers from joining the network.

#### **WHAT IS A CLAWBACK DUE TO ELIGIBILITY?**

Sometimes an insurance company will clawback money that it already paid a provider for services because it finds that it had inappropriately told the provider that the patient or client had insurance with them when that wasn't true. The insurance company's mistake becomes a big problem for the provider and represents a huge financial burden if it occurs.

#### **WHAT CAN WE DO?**

***Give your support to S.770!*** S.770 is a bill filed in the Massachusetts State Senate that seeks to limit this practice of clawbacks so that there is less risk to providers and they can be paid for the work that they do. We hope this will encourage providers to stay in insurance networks and continue to join more networks so that there can be more broad access to care across Massachusetts.
