Artist in Residence 2025



Program goals and outcomes

The goal of the artist in residence program at Mount St. Helens Institute is to foster creative work that is inspired by the unique ecosystem of the blast zone and that explores the connection between humans and this volcanic environment. This unpaid residency provides time and space for self-paced work and reflection in a majestic natural setting.

This program is for visual artists, writers, musicians, dancers, or other creatives who wish to inspire visitors, students, and teachers through their artistic expressions.

The Artist in Residence will work in partnership with our Youth Education and Events team- we encourage those who want to celebrate the young artists who visit us on field trips to apply!

We invite both emerging artists and practicing professionals. We look forward to receiving and reviewing your application materials. The selection process is informed by peer review, and based on the applicant's field(s) of practice. Each complete application is considered individually, and finalists will participate in an interview process. We strive to host residents from a diversity of backgrounds and practices. All applicants will be notified by email 8 weeks after the application window closes. MATERIALS NEEDED TO APPLY

Artist accommodations

The artist will have the opportunity to immerse themselves in the landscape of the blast zone by camping in our campground, complete with crater views. The campground is rustic, with access to our learning center a short ~5 minute walk away. The learning center has running water, flush toilets, and a kitchen that is shared with our program operations. We have extra tents, sleeping bags, and sleeping pads that can be utilized by the artist. This is a rugged and beautiful environment! Applicants should consider if this camping experience will suit them.



Some meals will be provided as shared meals with our program participants, and outside of scheduled programs, the artist is welcome to coordinate with our chef for the use of the kitchen. The learning center also provides an indoor workspace with tables, chairs, and crafting supplies from our education programming.

Constraints/Rules

- Your creative project must relate to nature in a specific way
- Artists must be 18 years of age or older
- Collaborative teams of up to 3 people may apply
- No pets allowed (inquire with us if you have a service animal)
- Our campground is not ADA accessible- contact us about other accommodations
- Background check required (we host youth programs)





Expectations of artist (donation, presentations, etc)

- At least one public presentation during visitor center open hours (between 10AM - 4PM daily June - October), coordinated with Forest Service staff. This brings the program full circle and serves to share the artist's experience and connect a broader public audience to public lands through the artist's direct experience.
- Donating at least one piece of artwork that can be displayed or used in the Science & Learning Center or for Mount St. Helens Institute/USFS outreach and education programs
- Participate in at least one Mount St. Helens Institute education program, offering a workshop, lesson, reading, performance, etc. to our program participants.
