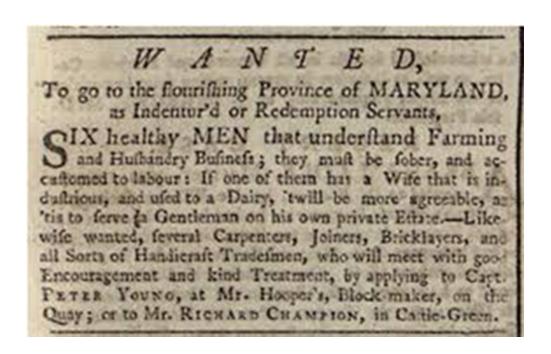


More labor was needed in the early colonies in North America. It was also expensive to move to the colonies and start a new life. Many immigrants, therefore, came over as indentured servants. A landowner in the colonies paid for their ocean passage and their living expenses in exchange for their labor on a farm or in a shop. The primary sources below show different perspectives on this practice.

Examine the following documents and make the decision about indentured servitude - Would you be willing to do be an indentured servant for a voyage to America?

Background Essay

Indentured Servants: Would you be willing to be one?

People from all social classes flocked to the newly established 13 British colonies. Many came for wealth or religious freedom, but a large group desired land. Land was scarce in England. In the New World one could obtain land by simply claiming it. One group that desired land was the low class, yet they could not afford to finance the voyage to America. One way they could pay for the trip was to sign up as an indentured servant. An indentured servant is a laborer who agreed to work without pay in exchange for a trip to America.

As an indentured servant, men and women were enslaved to the owner for an amount of time, usually 5 to 7 years. Often they were not treated well during their time of service. Once the time expired, they were given their freedom plus some goods and land, sometimes up to 15 acres, on which to start up their lives.

Indentured Servants first reached America in the 1610's in the newly formed colony of Jamestown. The men that first established the Jamestown colony faced many hardships which can be attributed to the fact that a majority of them were classified as "gentlemen" and not accustomed to working. Indentured Servants within the colony could provide the much needed labor and specialized skills that were necessary.

How did slaves differ from indentured servants? Slavery was unvoluntary unpaid labor. At first, there were far less slaves sin the colonies than indentured servants. These amounts shifted over time as more and more slaves were imported across the Middle Passage from Africa to the New World. These people were captured, put on ships and sent to the New World to work on the plantations. Although many died on the voyage across the Atlantic Ocean, the ones that survived were sold to the highest bidder and forced to work for life. These slaves had no rights granted to them by their owners. They were not even considered citizens.

This is to ome Motice. THAT the Ship ESTHER, Capt. John Wills, will be ready to fail for Maryland, some time in February, next: Any Terfon that hath a mind to go over as a Servant, will have necessary Lodging and Clothes as utual, to go by Indenture for a Term of Years; and any Tradefmen, who have a mind to go over, may go on the lame Terms, or Wages by the Year: If any Hosbandman hath a mind to go over with his Family, will have very good Encouragement, a Cooper that is a Work-man, may have good Wages by the Year, for a Term of Years, and to be employ'd in the Service of Capt. John Colvill; as likewife any Person who understands Brewing, and making Malt. All Persons, Men or Women, that have a mind to go over, may apply to Mr. Marthias Giles, in Love-lane, near Sandgate; or to Capt. Wills, who may be met with on boatd the faid Ship, now at Newcastle, who will treat with any Person, &c.

Document B

George Alsop's Account As An Indentured Servant

They whose cannot afford to purchase their own transportation over into *Mary-Land*, can live pleniously well if they give up four years of sordid liberty. And what's a four year's servitude to advantage a man all the remainder of his days, making his predecessors happy in his abilities, which he attained in such a small a time?

Now those that commit themselves unto the care of the Merchant to carry them over, they need not trouble themselves with any inquiries about their voyage; for there is such an honest care and provision made for them all the time they remain aboard the ship while they are sailing over. They will want for nothing that is necessary and convenient during the journey.

Some are always breathing forth filthy dregs of abusive lies, saying that those which are transported over here, are sold in open market for slaves. This is an untruth, for I so confidently believe they could not find one to parallel this. The servants here in *Mary-Land* have the least cause to complain, either for strictness of servitude, want of Provisions, or need of apparel.

For two months, when the Sun is hottest, they claim an ancient and customary privilege, to rest themselves three hours in the day within the house. This is undeniably granted to them that work in the fields. In the Winter time, which lasts three months (*viz.*) *December, January,* and *February*, they do little or no work or employment, save cutting of wood to make good fires to sit by. Unless their Ingenuity will prompt them to hunt the Deer, or Boar, or recreate themselves in Fowling, to slaughter the Swans.

He that's a Tradesman here in *Mary-Land* (though a Servant), lives as well as most common Handicrafts do in *London*, though they may want something of that Liberty which Freemen have, to go and come at their pleasure.

He that lives as a servant in this Province, must only serve four years, and when his time expires, his Master must give him fifty acres of land, corn for a full year, and three suits of apparel, and the tools to work. Not only are they free, but they are ready to set up for themselves, and when once entered, they live passingly well.

The Women that go over into this Province as Servants, have the best luck here as in any place of the world besides; for as soon as they land, they are courted for marriage, and a lot faster than would have happened back in London.

In short, touching the Servants of this Province, they live well in the time of their Service, and by their restrainment in that time, they are made capable of living much better when they come to be free.

Document C

THIS Indenture Witnesseth, that John Reid of freedhold in the County of Monnmouth Jersey by and with the Consent of his father John Riad of Sd place hath put himself, and by these Presents doth voluntarily, and of his own free Will and Accord put himself an Apprentice to Robert Livingston Jun of New York with him to live, and (after the Manner of an Apprentice) to Serve from the first Day of Novembr: Anno Domini, One Thousand Seven Hundred and Forty two till the full Term of five years be compleat and ended. During all which Term the said Apprentice his said Master faithfully shall serve, his Secrets keep, his lawfull Commands gladly every where obey: he shall do no Damage to His said Master nor see to be done by others without letting or giving Notice to his said master he shall not waste his said Masters Goods, nor lend them unlawfully to any, he shall not commit Fornication, nor contract Matrimony within the said Term. At Cards, Dice or any other unlawful Game, he shall not play, whereby his said Master may have Damage with his own Goods, nor the Goods of others within the said Term, without Lisence [sic] from his said Master, he shall neither buy not [sic] sell, he shall not absent himself Day nor Night from his said Masters Service without his Leave, nor haunt Ale-Houses, Taverns or Play-Houses; but in all Things as a faithful Apprentice he shall behave himself to his said Master and all his during the said Term. And the said Master during the said Term shall by the best Means or Method that he can, Teach or cause the said Apprentice to be Taught the Art and Mystery of a Marchent [sic] And also shall find an provide unto the said Apprentice sufficient meat Drink and Lodging

For the true Perfomance of all and every the said Covenants and Agreements, either of the said Parties bind themselves unto the other by these Presents. *In Witness* whereof they have hereunto interchangeably put their Hands and Seals this first Day of Novembr. in the Sixteenth Year of His Majesty's Reign *Annoq*; [sic] *Domini*, One Thousand Seven Hundred and Forty Two,

The Indenture Contract of Roger Jones (1688)

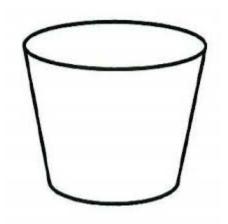
Roger Jones, servant to Mr. William Churchill, comes and acknowledges that he is freely willing to serve his Master Seven Years from his arrival in Virginia, the said Churchill promising that he will employ his said servant in the store and other areas and not employ him in common working in the ground [no tobacco planting]. At the time of his freedom, said Churchill will give to said Jones a new suit, shoes, and hat [but no land].
