Teleconference November 28, 2023, 14-1530 UTC, 16-1730 CET, 10-1130 EDT, 6-730 AKDT

1. Welcome and Review of Agenda

The ROADS Advisory Panel (AP) Co-chairs, Sandy Starkweather and Lauren Divine opened the meeting and welcomed participants (Appendix 1). Lauren provided an overview of today's agenda (Appendix 2) noting that meeting documents are available at the following workspace:

2. Review of Minutes

3. Breakout Discussion for the Review of the Wildfire Documentation

Sandy set the context for the breakout groups stating that the AP has been primarily in a building and constituting phase to date and that work on the evaluations of the Expert Panels will be an important task in the future. To assist in making the evaluation process as straight forward as possible, she stated that today's breakout groups will work together to evaluate and discuss the wildfire documentation. This will provide an opportunity for all members to become comfortable with the evaluation process. Four breakout groups were created for discussion – two groups were comprised of individuals who had completed the evaluation process, and two other groups were comprised of individuals who were still working through the evaluation. Some of the general concerns related to consistency across the reviewers in scoring the documentation, and challenges in using different web browsers to view the evaluation tables/links/visuals. More specifically on the wildfire documentation itself, comments consistently considered the material to be good to very good in content. Comments included that: the material being very focused on Finnish data (versus on broader Scandinavian and pan-Arctic); very positive reception of the societal-benefits tree; Indigenous relations are very focussed on Saami; further clarity could be provided by having an introductory paragraph

that explained the hierarchy of themes and SAVs. There was discussion that the early EP efforts will likely be developed in a regional context (that would grow to be pan-Arctic) and that the AP will need to be supportive of these early regional efforts to assist their growth. Sandy thanked members for the discussion and input, noting that there is still more work to finetune both the template and evaluation form comments.

The next step will be feedback to the Finnish leads of the Wildfire documentation, with a summary of the evaluation comments. Jan Rene Larsen agreed to consolidate the comments by early December and Mikko Strahlendorff will serve as the AP Champion on this EP. In addition, the ROADS AP Executive will meet to discuss the documentation needs for Phase II.

4. Review of Documentation and Calls for Assistance:

a. Input for Phase III documentation: Sandy outlined that work will be required on developing Phase III (observing and data system requirements) documentation, as the EPs advance through the phases. Aspects of requirements, harmonization of observing practices, data sharing, and data dissemination need to be further refined. While an early draft of Phase III documentation has been prepared, a small workshop could be held to advance efforts/learn lessons from initiatives like ELOKA, SIKU (Canada), SIOS, T-MOSAIC, DBO and others. The proposed timeline would aim to have the Phase III documentation prepared by April-June 2024.

ACTION ITEM: AP members were asked to provide contacts of examples of good documentation systems relating to observing and data systems requirements that would valuable to learn from/adapt into the ROADS AP Phase III documentation. Any member interested in working on developing Phase III would be welcomed.

- b. <u>Indigenous Engagement Documentation</u> Update: Margaret Rudolf spoke of the strategy to engage additional Indigenous representation from missing groups (Canada, Russia, Europe), and in engaging Russian Indigenous Peoples. Efforts are underway and this agenda item will be discussed more fully at the December ROADS AP meeting.
