Deadlines

1. For the House:

- Submit written testimony and/or sign up for oral testimony on Friday, 2/10 from 8 am 3 pm
 - o Link to sign up
 - If you are interested in speaking at the hearing, please let us know! We're coordinating speakers.
- The hearing will be in-person on 2/14 starting at 1:00 pm in front of the House Health and Government Operations Committee

2. For the Senate:

- Submit written testimony and/or sign up for oral testimony on Monday, 2/27 from 8 am 3 pm
 - Link to sign up
 - If you are interested in speaking at the hearing, please let us know! We're coordinating speakers.
- The hearing will be in-person on 2/28 starting at 1:00 pm in front of the Senate Finance Committee

Questions to think about for testimony

- Introduce yourself What do you want legislators to know about you and your experience in relation to the bill topic?
- What are the barriers that you or other trans people face to accessing healthcare insurance coverage?
- In what ways have you or the communities you serve struggled because of Medicaid's limited coverage for gender-affirming care?
- What joy/positivity would the bill passing bring to your life?
- Why do you care about this bill? How would it impact you?
- What unique viewpoint can you bring to this issue?
- What personal stories, facts, and/or data do you have to share?

How to title written testimony

- At the top, include this information:
 - o Whether you support the bill and the bill number
 - o Name of Committee hearing the bill
 - Date of the hearing
 - "Testimony of [your name, your organization if any]"
- Example:
 - O SUPPORT HB 283
 - House Health and Government Operations Committee
 - o February 14, 2023
 - Testimony of [your name], [your organization, if any]

- Title the document with the bill number, your name, and position
 - o Ex. "SB XXX_[your name]_fav" or "HB 283_[your name]_fav"
- There is an example of written testimony on the last page of this document

How to submit written testimony

- Save your testimony as a pdf
- Submit your testimony on My MGA
 - Go to http://mgaleg.maryland.gov/mgawebsite/
 - Click the "My MGA" icon in the very top right corner of the webpage.
 - Click "Create a MyMGA tracking account"
 - Enter your information in the fields (name, email...)
 - Click the "Register" button
 - Go to your email to confirm your account by clicking the link in the email. Sign in using the account information you created.
 - Log into your My MGA account
 - O Click "Witness Signup" from the menu on the left
 - Once you find your bill #, click the "Position" drop down to choose "Favorable". Click the
 "Testimony" drop down to click "Written". Then you just need to click "Upload File" and
 select the file from your computer. Click "Save" when you are finished.
 - Your testimony file must be a PDF. If you have it as a word document, you can "save as" in the format PDF.
