1. Student goes online to post pictures and inappropriate messages (camera shows student typing at computer and then zooms in to see what they are posting)

2. Who sees what you post?

- Family - quick scene of mom disgusted about postings
- College admissions - maybe write "rejected" on the application after Googling the name

Casey, I think we need to be hyper vigilant in this assignment about using any names like Google or Facebook...

Makes sense, I'm for it.

- Employers - person looking at application and then looking at the google results, shaking their head)

I still think it would be a little more original if we used the pics circling over their head instead of referring to Facebook. I also think we need to be very careful about singling out Facebook...we need to refer to Social Media or something like that...

I am not sure how to get the pictures to float over the head? Maybe more focus on the facial expressions more than the screen. Maybe the student could be talking on the phone about what they are about to post. That way a name could not be mentioned and we do not have to fabricate any pictures.

The screen does not need to be shown. Only the face of the person lit by it.

I can do this...it's in the editing...not in the photography....you would insert stills into the footage that have been "photoshopped"...

- Hackers - identity theft - maybe create a fake license with person's info such as address and birthday but have a girls name but have a guy's picture for the pic ID part, along with a credit card with that name on it.

This has been done before...perhaps rethink this?

I think we need to concentrate on one "danger". Since it would only last one minute. The concept of college or job applications being denied is enough.

I agree with Ana.

This has been cut from the script.

3. What can you do to prevent this?

- Be careful about what information you put (have that person erase their personal info such as birthday)
- Don't write something that may come back to haunt you
- Be careful of pictures that you post

Narration Script

Scene 1 - A student logs on to a social site (ex. Facebook) and had mean/uncalled for posts about another made up person and post a picture of themselves partying a little too much. Student stops to think about what they are posting right before hitting the publish button - transition effect to show thinking mode.

Info slide - Title “What Could Happen If I Post This?” Or voiceover?

I agree most of the content should be voiced-over. That way we do not need to show any images singling out any particular social network.

Scene 2 - “The Employer” - A possible employer is sifting through applications and logs on to Facebook to check on possible highers. The employer looks on Facebook and notices the postings and shakes head in disgust. Camera shows employer tossing that person’s application in the trash with a sigh of disappointment.

*Needs: Can film in a principal’s office and possibly bribe the principal to take part in the filming. The logic to this being they are already dressed up and have a professional employers set up ready to go. We will have to create a fake Facebook ** (see comments below) page to load on the computer to show the employer looking at in disgust. * Pam, you created an awesome fake in our last partner class, do you still have it? * We will also have to some applications printed so that one can be thrown away.*

Casey, that FB page was specific to the assignment. I think we might be stepping on toes with that (copyright). Perhaps just a big FB or some other pseudonym ...we don’t actually need a closeup of the page. That’s the way that they do it on TV frequently. We probably want to be very careful about actually using their page or a simulation. It would be easier to zoom in on a big FB or MYPAGE or something else and then zoom out to the picture. If you’ve ever noticed, they don’t actually use Facebook on the TV programs unless it’s a real story.

Scene 3 - “Family” - Mom/Dad is checking on their own Facebook page and sees what their child has posted and has a look of shock on their face, as they call out the student’s name to have them explain this posting online.

Needs: can be filmed in a home office setting. Need a person who could fit the part of a parent, I would do this but I am too baby-faced to pull it off realistically (I still get carded at the theaters :p) Camera shows parent logging in and sees the posting of the student.

Scene 4 - “College Admissions Office” - A college admissions officer is looking through applications and googles the name. Shot of their shocked face as they see what appears on the screen. They write/stamps “rejected” on the application. I just found a website on this that says admissions offices don’t really have time to check

FB pages...but parents of potential roommates do!

Some colleges will actually take the time to do it. Depending on the “quality” of the college and the restrictions on admissions.

Needs - A person in professional clothes in an office. Could go to a college campus and have them put a rejected stamp on the application. Need an application filled out to be rejected. (I can create this in a lot less time...and I work at the admin. bldg. so it would be easy to get someone to let me get this shot.

**Scene 5 - “Be Careful of What You Post...You Don’t Know Who Can See It” -
Transition back to the student who deletes what he is about to post. Student logs back on to Facebook and deletes the personal and/or negative postings. The student turns to the camera after editing their mistakes and gives a thumbs up. I really like this! (LOL - It’s very Ferris Bueller!!)**

Needs - scene goes back to the home office. the student edits their posting with the camera catching the student and can add a screen video recording of what has been edited.

**** I was just trying to throw out a general idea of something we could do. feel free to modify or change as needed. - Casey**
