 - Nicole and Dale attended the meeting to discuss the coaching position. He applied for the A team but was under the impression that he applied for the highest caliber team. Dale read out a letter that he sent out regarding this decision. Nicole talked about why we put AA and A as an option when we usually never have enough for one team. There was discussion that the AA coach would coach the highest level, even if that turned out to be a B team. The letter is quoted below.

 - Dear Board of Directors,

As the 2023/24 U15AA head coach, I applied for the U15 representative team head coach position for the 2024/25 season. At the interview, I explained to Matt Steeves and Martin. Murphy that I selected A on the application as last season there was only one U15 representation team that played at best A level hockey. I was clear I was applying for the first team even though I had selected A. I was notified on May 28 2024 that I was the successful applicant for the team I applied for. I was aware that there may have been other applicants (including applicants for an A team). I messaged Matt Steeves and asked if I was successful for A or AA. He replied AA. Shortly after I began to hear another individual was also under the impression he was selected as head coach for U15 AA. I messaged Matt Steeves and asked for clarification. He responded, I applied for A and was selected as head coach for A. At the TMHA AGM the list of representative coaches

was communicated to the membership. I was listed as the U15A head coach. As this was presented, several board members openly remarked that the U15 head coaches (A & Description of the listed backwards and needed to be switched. I contacted Jessie Hordecki that evening and she confirmed that the minutes of the last board meeting (May 27 2024) would reflect the board voted and approved myself as the U15AA head coach. have been encouraged to attend the next board meeting however I am requesting this error be corrected immediately. The board has passed a motion approving myself as U15AA head coach. The correct information should be provided to the applicants and membership immediately. I look forward to your prompt response in writing. Thank you.

 - The lowdown: Requesting a change to our fundraising policy for representative teams.
 Wants to allow \$200 of fundraising funds for each player to go toward potential clothing orders.

I am writing to the board to request a policy change to TMHA's rep team Fundraising Policy.

Our current policy 5.16 reads:

- 5.16 Fundraising Policies:
- n) All fundraising and sponsorship money is to be used for team expenses only, team travel, tournament registration fees, administration costs in support of team activities, ice costs, team meals during home tournaments, first aid kits and sponsor photos.
- o) Fundraising and sponsorship money cannot be used for the purchase of clothing, parties, team pictures, tickets to sporting events or any other item that is above and beyond the costs for the team to operate; these items must be paid with parent payment money.

Requested/Proposed Change:

- n) All fundraising and sponsorship money is to be used for team expenses only, team travel, tournament registration fees, administration costs in support of team activities, ice costs, team meals during home tournaments, first aid kits, sponsor photos **and up to \$200 of Team Swag.**
- o) Fundraising and sponsorship money cannot be used for the purchase of clothing, any expenses related to parties, team pictures, tickets to sporting events or any other item that is above and beyond the costs for the team to operate; these items must be paid with parent payment money.

Justification for proposed change:

The identity of a TEAM is vital in any competitive sport and team swag is an important component of any team's identity. This policy change would permit parents to use fundraising dollars or sponsor dollars to purchase up to \$200 of team swag and would be the price of approximately 1 tracksuit - which in my opinion is not unreasonable to have

when you join a competitive team and should be considered as a team expense. (Tracksuits last year were \$200 - \$125 for the jacket and \$75 for the pants)

It would remove some financial burden on parents as well as some pressure for some parents who may already struggle to find the funds necessary for travel and other expenses related to competitive hockey. This change would permit/allow them to fundraise for this if so desired.

By placing a cap on the amount would ensure parents do not purchase an unreasonable amount of team swag just because or use the funds for ie: other children in their family. As you all know kids grow at a fast pace and reusing a tracksuit from year to year is just not an option for The majority of parents.

This past weekend I was approached by a community member who asked me why he was returned some of his sponsorship money and he respectfully advised that he really did not want it returned. I reminded him that he did not have to accept it and could have provided it to TMHA directly. He advised me that he wanted it to go to that child directly for their hockey needs. I think most sponsors hold a similar opinion. The money provided the year prior is now off their books as it is a new year, so it does make it challenging for some businesses. Additionally, having returned funds does not give our sponsor the best optics - as it gives an impression that their money is not needed and may perhaps make them less likely to donate to future players. Should the board feel the proposed \$200 should be more or less - please feel free to modify my proposal based on what the board sees fit following your discussion regarding accepting this change..
