Great News: All-Electric Building Act Introduced!

On November 1, Senator Kavanagh and Assemblymember Gallagher announced the introduction of the <u>All-Electric Building Act</u>, which is part of the RHN legislative package.

This bill would help end fossil fuel expansion by banning fossil fuel systems in most new buildings beginning in 2024.

If passed, the bill would make New York the first state in the country to enact a statewide all-electric code for new buildings! The bill also requires the development of electric rates, incentives, and other policies to ensure the energy for all-electric buildings will be affordable for New York's residents.
