(AI) Instructional Support Levy (ISL) The Board of Directors of the East Union Community School District, in the Counties of Clarke, Madison, Ringgold, and Union, State of Iowa, will hold a hearing upon its Resolution to Consider Continued Participation in the Instructional Support Program. The hearing will be held in the Collaborative Learning Center, 1916 High School Drive, Afton, Iowa 50830, on February 19, 2024, at 5:30 P.M.						
	The Board of Directors is considering continued participation in the Instructional Support Program as provided in Sections 257.18 through 257.21, Code of Iowa, for a period of five years, commencing with the fiscal year ending June 30, 2025.						
	Additional funding for the Instructional Support Program for a budget year will be determined annually by the Board of Directors and will not exceed ten percent (10%) of the total regular program district cost for the budget year and moneys received under Section 257.14, Code of Iowa, as a budget adjustment for the budget year.						
	Moneys received by the District for the Instructional Support Program may be used for any general fund purpose.						
	The Instructional Support Program shall be funded by instructional support state aid and a combination instructional support property tax levied annually upon the taxable property within the School District commencing with the levy of property taxes for collection in the fiscal year ending June 30, 2025, and an instructional support income surtax imposed annually, the percent of income surtax to be determined by the Board for each budget year to be imposed upon the state individual income tax of each individual income taxpayer resident in the School District on December 31, 2024, and each year thereafter.						
	Recommendation : RESOLVED, that the Board of Directors of EAST UNION community school district, will hold a public hearing over the Instructional Support Levy on February 19, 2024 at 5:30 pm.
