

## Fraser Public Schools Phase 4 Reopening Procedures

- 1. <u>Frequently touched</u> surfaces including light switches, doors, benches, bathrooms, must undergo cleaning at least every four hours with either an <u>EPA-approved disinfectant</u> or diluted bleach solution.
  - It's very important to remember that our shift in cleaning will be for HEALTH and not Appearance.
  - Fraser Public Schools purchased 400 spray bottles and triggers. That's one for each classroom. These spray bottles will be labeled, filled with an EPA-approved chemical, by the building custodian through our dispensing machines, and placed in every classroom.
    - i. Hillyard #25 sanitizer will be issued to all kindergarten through second grade classrooms.
    - ii. Hillyard #19 disinfectant will be issued to all third through twelfth grade classrooms.
    - ii. Hillyard QT3 will be used in and on our buses.
  - Each room will also receive one box of disposable wipes, one pair of reusable washable gloves, a clear plastic reusable face shield and a one box of face masks.
  - The district will need help from the teachers to sanitize all highly touched surfaces.

## **CLEANING KIT**









• Fraser Public Schools has purchased nine additional Clorox 360 electrostatic sanitizing machines with the appropriate chemical. That's one machine per building. These machines will be used each night to sanitize all school buildings.







- The building custodian will sanitize the restrooms, both community and private in each building once halfway through the school day.
- 2. Libraries, computer labs, arts, and other hands- on classrooms must undergo cleaning after every class period with either an <a href="EPA-approved disinfectant">EPA-approved disinfectant</a> or diluted bleach solution. Fraser Public Schools purchased 400 spray bottles and triggers. That's one for each classroom. These spray bottles will be labeled, filled with an EPA-approved chemical, by the building custodian through our dispensing machines, and placed in every classroom.
  - i. Hillyard #25 sanitizer will be issued to all kindergarten through second grade classrooms.
  - ii. Hillyard #19 disinfectant will be issued to all third through twelfth grade classrooms.
- 3. Student desks must be wiped down with either an <a href="EPA-approved disinfectant">EPA-approved disinfectant</a> or diluted bleach solution after every class period. Fraser Public Schools purchased 400 spray bottles and triggers. That's one for each classroom. These spray bottles will be labeled, filled with an EPA-approved chemical, by the building custodian through our dispensing machines, and placed in every classroom.
  - i. Hillyard #25 sanitizer will be issued to all kindergarten through second grade classrooms.
  - ii. Hillyard #19 disinfectant will be issued to all third through twelfth grade classrooms.

- Each room will also receive one box of disposable wipes, one pair of reusable washable gloves, a clear plastic reusable face shield and a one box of face masks.
- The district will need help from the teachers to sanitize all highly touched surfaces.
- 4. Playground structures must continue to undergo normal routine cleaning, but using an <u>EPA-approved disinfectant</u> is <u>unnecessary.</u> Fraser Public Schools currently does not sanitize outdoor play equipment. We will continue to let mother nature and the natural elements sanitize our outdoor play equipment.
- 5. Ensure safe and correct use and storage of cleaning and disinfection products, including storing products securely away from children, and with adequate ventilation when staff use products. All of the district's chemicals are stored in locked custodial closets and are dispensed through a manufactured dispensing system. Which insures a proper dilution rate. Our bottles are properly marked and we have Safety Data Sheets stored at every building.



6. Staff must wear gloves, surgical mask, and faceshield when performing all cleaning activities.
