## Introduction:

Update: As of 03/31/22 Honeynukes is now going by their 2019 handle, Cynnabonz / Cynnabonz\_

Hello, Everyone: my names' Cynder and I have to address an ongoing issue with the user currently known as Cynnabonz. Cynnabonz and Is' history goes back a few years starting around early 2019 - late 2018 and has been a recurring cycle of impersonation, design theft and unprovoked slander. For many years I have tried to resolve this as peacefully as possible but unfortunately Cynnabonz continuously oversteps agreements to halt this behavior.

In this official public notice I will address multiple counts of design theft, impersonation and harmful falsities that Cynnabonz has committed not only towards myself but a few other individuals as well. There will be more incidents that although I will not include here; I will show and go into if requested. I will be going over **key** events that I feel are most relevant.

From stolen usernames, names, personality traits, designs and heavily referenced or traced art; no matter how many times I have pleaded this behavior has not been discontinued.

Cynnabonz uses They/Them pronouns the last we spoke.

Disclaimer: Cynnabonz repeatedly claims me to be the stalker, I obtain ALL of my information from a mutual who follows Cynnabonz and has gotten art from them in the recent past. All that I am made aware of is posted publicly as well. That is /NOT/ stalking; I have a right to know when Cynnabonz is being problematic regarding my designs and identity. The mutual does NOT have malicious means or intent in regards to Cynnabonz; they just share their concerns with me, I never once specifically asked anyone to keep an eye on Cynnabonz' stuff, I've had multiple people

through the years come to /me/ in regards to the uncanny resemblance between both our characters, interests and identities.

Edit: As of April 2022 Cynnabonz is now using the username Cynniemoo for their personal accounts, I have been using Cynnimoo for roughly over a year now for my own personal accounts. This is not the first time they've taken my username and slightly altered it for their own use.





# False beware Cynnabonz Placed on me:

In February of 2019 Cynnabonz, at the time going by Minx / Link had made a Night Fury original character named Cynder Kaida: Cynnabonz had known me prior to this and had known that my name is Cynder and my long-time sona is a Quantum Deathclaw sharing the same name.

Cynnabonz alongside an ex friend of theirs decided to make a beware against me claiming me to have not only been stalking them but to have copied the Night Fury oc whom was created long after my own sona; they then proceeded to look through my Deviantart favorites and contact all the artists I had recently commissioned spreading the falsities shown below. This has since caused a handful of said artists to no longer wish to do business with me due to the drama caused by it.

March 20th and onwards, art was stolen. Characters were stolen. Pictured past the Saana image are art from PlutoniumClaw- art of stolen and heavily referenced, copied OCs down to the marking.

Cynder has multiple accounts. Princxss-Cynder, PumpkinCynnie, Cynnera, QuantumClaw and NukaCynnie are her.

Volga has twice as many. PlutoniumClaw, The-Twili-Angel, King-Volga. The list goes on.

It's disgusting. The original sona, Cynder Kaida, was made well into early February, some pieces of art only being made in late March. Cynder is a comfort character for Link, and he's being stolen from Link for some thieving, conniving fucking whores who deserve nothing.


They deserve absolutely nothing. They've stolen OCs of Link's in the past-including a halloween one, one that looks candy corn. She's literally called fucking Candy- and you'll see it if you stalk through the favorites of the PumpkinCynnie account.

This isn't okay. This will never, ever be okay. They're stalking Link to steal the oc markings and the coloring to a fucking exact.

Share this around. They deserve no fucking sympathy.



# Incredibly similar character concept 2019:

A few months later in July of 2019 I had decided to publicly post my new characters reference, a quantum deathclaw + scorchbeast hybrid named Nuka: almost directly after Cynnabonz, now going by Sal at this time created a quantum deathclaw x scorchbeast hybrid character named Nuka.




#### Addition:

I completely understand that certain things like species, names and colors can NOT be claimed but as you will see it adds up too much to be a coincidence, especially with Cynnabonz' and Is' recent encounter prior to this incident. There are many varieties of deathclaw, the quantum variant not even being added to the game (cut content) and for Cynnabonz to choose the quantum variant specifically on top of hybridizing it with scorchbeast (no other prior scorchclaw hybrid ocs had been made prior to this) and using the same name, Nuka within a couple weeks at most of me publicly posting mine seems to be way too specific to be purely done without reference to my characters once more.

# Claiming someone forced them to make and use the Night Fury OC and make the false beware 2020:

In early 2020 Cynnabonz had reached out to me; offering friendship and to resolve past incidents, in hopes of being able to let this be put to rest I accepted. During this time I asked Cynnabonz what had caused them to slander me and mimic my designs; their response was that they had been forced into making a design similar to mine and slander post towards my sona and I. Cynnabonz claims they were physically abused into using this sona, yet they willingly used it for around 3-4 months.



#### IN ADDITION:

Cynnabonz and I had tried to speak on friendship terms once prior to this in late 2019, after the scorchclaw hybrid incident; it ended with our friendship being overall toxic and unsettling on both sides for both relevant and irrelevant reasons and communication was once more halted.

In mid 2020 during the speaking period shown above Cynnabonz had given me a handful of characters; Cynder Kaida the Night Fury being one of them. I was originally under the agreement that I would pay for them but due to unforeseen circumstances that fell through. I had offered to send them back to Cynnabonz multiple times whom insisted that I keep them as a gift. This information will be important for later.

# ANOTHER HEAVILY REFERENCED DEATHCLAW DESIGN: LATE 2020:

In Fall of 2020 a previous mutual of both Cynnabonz and I had let me know that Cynnabonz was yet again using a similar quantum deathclaw design; still named Nuka but this time inspired primarily off of a user named Mimaahs quantum deathclaw, Malakiel. This version of Cynnabonz' Nuka shared minor design traits with mine such as part of the same name and incredibly identical outfits and major design placement similarities with Mimaahs Malakiel.

When I brought it to Mimaahs' attention they alerted me that they had not been asked permission to make such a heavily inspired design and were discouraged that Cynnabonz had mimicked some key design traits of theirs.






Cynnabonz going back on previous claims seen above that they were forced into making and using the Night Fury oc whilst trying to force me to change her design and give her back nearly 4 months after giving all ownership to me:


As previously mentioned in around May of 2020 Cynnabonz had gifted me a handful of characters, one of them being Cynder Kaida the Night Fury; in late November of 2020 Cynnabonz had asked me to change an aspect of her design, the choker she had around her neck. I politely declined as I had not been asked to make any design changes at the time of being granted ownership; and had since not only purchased art of the character, but had grown attached to it as well. Cynnabonz then proceeded to ask for the character back, for the reasons above I declined to which they had escalated to spamming me; using reasons such as them being the creator to **demand the design back by force**. During this conversation they backtracked on their previous claims of Cynder Kaida being a character that was forced onto them, along with the previous slander I had to endure along with it.

Cynder Kaida is being referred to as 'Aoki' below as she had undergone a rename.


As seen not only did Cynnabonz try to use themself being the design creator against me; they also lied to try and guilt trip me and continuously pressed when told no. Cynnabonz expressed anger towards not being given back a character and felt as if they could 'change their mind' about me having her and acted as if I disrespected them by making changes to a character I now rightfully owned. This situation was incredibly anxiety-inducing for me.

# Reuploaded Character without permission:


In late 2020 while still on speaking terms I had asked Cynnabonz if they were interested in me commissioning an artist to make a crackship child out of their ex sona Avalon and my oc Shirina; they agreed and I decided to let them co-own the result as their sona was one of the 'parents'.

I had assumed that the co-ownership had ceased when we quit communication for a final time in February, but a couple months later I was made aware that Cynnabonz not only had reuploaded the oc without discussion with me: but named it as well.



I understand this situation is a bit iffy but I feel as if Cynnabonz should have reached out to me if they still

wished to use the oc and I would have gladly worked something out with them; not them randomly uploading her and coming up with their own name / lore for her.

# Public response towards Cynnabonz prior to the Wickerbeast incident

In April of 2021 Cynnabonz commented on my public blacklist asking me to remove them as they felt we had resolved the issue; although I was originally fine with removing them I realized how uncomfortable they still made me and responded with the message in the comment below; addressing my unresolved issues with Cynnabonz. It was a few hours later that they re-uploaded the aforementioned wickerbeast character and I published the first draft of my beware publicly in response.



# Cynnabonz slandering me in DMs, claiming me to stalk and commission artists that they had.

An ex mutual very recently alerted me that Cynnabonz had screenshotted a comment of mine on an artists art piece I had made and sent it to their dms, claiming me to be commissioning the same artists they had intentionally.


There was at least a 3 month gap in between when they had commissioned said artist and I had; the artist is primarily a Spyro artist so I had found them through their TLOS art; not through Cynnabonz. I had also been watching them for a considerable amount of time prior to Cynnabonz commissioning them.

Anyone can commission whoever they please; so I feel this was a very unnecessary attempt at sullying my name yet again, and also a good example of the hearsay regarding me that Cynnabonz will attempt.

The artist has since realized the uncanny similarities between Cynnabonz and I and is no longer comfortable taking orders from Cynnabonz as long as their characters so heavily resemble mine along with their personal identity.

The artist is kept anon as they are my friend. If they wish to come forward I will leave that up to them.







# Recently giving away a character they'd given me years ago and also admitting to stalking my profiles and using my personal characters and name as as heavy inspiration

In December of 2018 Cynnabonz gifted me a pony named Hazel Willows as they had bad connections with the oc to our shared abuser. In February of 2019 they posted the same character back up for sale and seemingly sold it to an ex friend.

Within this same conversation I also recovered solid proof of Cynnabonz admitting to copying both my personal name and characters, and them getting both the name and species from me directly, alongside Cynnabonz promising yet again to not repeat these actions.

# Atlas, similar pony design:

In October of 2020 Cynnabonz created a ponysona named Atlas at the same time in which she was using the copied deathclaw 'Nuka' as their fursona, Atlas shared key design traits to my ponysonas previous design. Originally Cynnabonz claimed that Atlas was designed by a friend with themes such as fall and berries in mind (a common excuse Cynnabonz seems to claim with these similar designs) only to later change their story and claim it to be be a pony they designed inspired off of Cynder from the Spyro franchise.

I will state yet again that I know I don't own nor can claim concept ideas involving specific colors or canon characters; but this yet again is no coincidence given our past history. Although the design does have it's differences which I won't deny, I am adding this in as it all adds up especially as a reoccurring issue spanning throughout multiple years.

Atlas shares key design traits with my ponysonas original design (created in early 2019) such has;

- -Hair color (black with a fade)
- -Hair style
- -Use of markings
- -Colored ear tips
- -Bat style ears
- -Underbelly placement







# sona named Cynder:

Cynnabonz' most recent problematic character is their current mascot: a deathclaw / cow named Cynder; for the sake of confusion I will be referring to Cynnabonz' mascot as Lorelei;

In early 2021 Cynnabonz had made themselves a truesona: a pony oc named Lorelei whom I had at one point even had an oc ship with; sometime after Cynnabonz and I had ceased contact for the final time around February of 2021 Cynnabonz had renamed Lorelei to Yuna and had redesigned her to be more cow based instead of pony.








At the time of the design above being used I had decided to officially add deathclaw into my fursonas genes; at the time my fursona was a highland brahmin / cow named Nala (Nala had been in use prior to Cynnabonz' redesign of Lorelei) and my Truesona was Cynder, the quantum deathclaw previously mentioned.

In May of 2021 I publicly released an image depicting Nalas' new design: an alpha quantum deathclaw + highland brahmin (cow) hybrid; also renaming her from Nala to Cynni / Cynder as she was a sona.



Cynni (my cowclaw) has a black haired + cyan claws + innards main palate which was inspired off my truesona, this was posted publicly to Toyhouse on the same date.



A few months later in early October of 2021 Cynnabonz had decided to make a major redesign to Lorelei; this time making the cow genes official and adding in quantum deathclaw genes; making it a Quantum deathclaw / cow hybrid, also named Cynder.

Cynnabonz decided to personally go by Cynder instead of Sal at this time as well.

Along with the major design update Cynnabonz put this notice up on their profile, seemingly to try and

evade being held accountable for their past design issues and once more, accuse me of being a slanderer + thief.

In addition: I will say once more that I fully understand certain things can NOT be fully claimed; such as species or names but given Cynnabonz' and Is' consistent history this just doesnt add up as a harmless coincidence. Lorelei went through a drastic change to become the quantum cowclaw it is today. Design 1 + 2 are both actively in use.

You will notice multiple key design similarities:

- -The name Cynder, not commonly used
- -The use of the quantum variented deathclaw specifically
- -Cyan innards and blood
- -Sickle claws on the feet

- -Tusks followed by fangs on the maw
- -Cyan pawpads on the feet
- -Cyan pawpads on the hand (Design 2)
- -The general horn shape + the cyan ridges on them
- -The horns now being the same general shape and colors (Black + cyan) (Design 2)
- -Middle foot claw being longer than the other two (Design 2)
- -solid cyan claws and spines (Design 2)
- -Cynder (from Spyro) markings on arms, using my PERSONAL design of them, NOT the canon markings roughly a month after I posted a closeup of my Cowclaw Cynders current design with Cynder markings(Design 2)
- -Tail spines (Design 2)
- -The cyan being on the same spectrum, Cynnabonz just using a slightly darker variant (Design 2)

There are multiple ways a cowclaws body structure could of been thought of as well, yet Cynnabonz' Cynder shares ;practically the same body build + hybridization traits as mine.

#### EDIT: 3/18/22:

A user was kind enough to inform me (keeping them anonymous as requested) that Cynnabonz is *still* it with copying of distinguishing design traits;

They've now updated their cowclaw to have full on Cynder markings, a very distinguishing pre-existing trait of my own. They are also being drawn in the same unique style of mine:








**In addition:** I have censored both of our previous Facebook names here for privacy reasons. The sona in question was at the time a female version of previous user King-Volgas sona, Volga; at the time of creation Cynnabonz had had permission from him to create such a similar design, but after events between the two that permission had been revoked and Cynnabonz had agreed to no longer use their version. I was not trying to force Cynnabonz to talk to someone they didn't want to, but permission is needed to make an incredibly similar design based off of someone elses.

### Stolen username 2018:

In late 2018 around mid December my public art username at the time was Floofy-Cynnie, Cynnabonz had decided to privately start signing their art under said username and rebrand themselves under Floofy-Cynnie + Cynnie-Floof.





One thing Cynnabonz tries to say in their own defense is that they are inspired off of the character




# OTHER USERS NEGATIVE INTERACTIONS WITH Cynnabonz:




## Nerdinqq:



# In conclusion:

This is just unfortunately the tip of the iceberg between Cynnabonz and I; although I wish no harm towards Cynnabonz or their friends, it has been tiring being in this cycle for years. For the longest time I was too scared to allow myself to publicly post new characters or likings, I felt as if I needed to guard my truesona 24/7 due to Cynnabonz' constant mimicking.

It's been mentally tiring, my anxiety has skyrocketed since the start of all this and it was a leading cause of me needing to be placed on anti anxiety + PTSD medication (which I can provide signed documents for

if need be). This has taken such a toll on my mental health and it's time for it to end; having Cynnabonz mimick a good amount of things dear to me and spread such harmful falsities has tattered my mental state to the point of diagnosed PTSD.

It is also incredibly unsettling that they are now choosing to go by 'Cynder' personally, I understand that once more, things such as names can NOT be claimed, but given our history it makes me incredibly uncomfortable and has hurt my self confidence and individuality paired with their harmful mimicking + slander.

But our shared experience had us both acting in unfavorable ways; and I take full responsibility for the unfair things I have done but at the end of the day we are both victims.

I have apologized to Cynnabonz multiple times through the years and have done everything in my power to put this behind us both.

This repetitive circle needs to end, its incredibly unhealthy for all involved.
