URLs change; I cannot monitor the changes constantly. Some have paywalls. If any link is dead or has a paywall, use a browser to retrieve the source or look for it in the library database. Sometimes the same newspaper or magazine source (but not the same academic source) has two titles, one online the other in print. As a result, when looking for these sources, ignore the database's title field. Instead, use the author's name and set the dates two or three days before and two or three days after the publication date.

Because *Water* is about 1930s India, read the entries about that country. Then choose two or three other nations in different continents, with different traditions and at different levels of economic and social development. This background information ought to help you write a better interpretative essay.



Per my searches, this is the only or one of the few sources reporting that the new Family Code outlaws child marriage. Though child marriage is not a Cuban tradition, the prior code, enacted in 1975, permitted marriage of girls at 14 and boys at 16, with parental permission. The new code states that no one under 18, the age of legal adulthood, can marry (Artículos 204 & 205). Unlike most press reports that focused on the new Code's marriage equality provisions, the article also reports that the new Code addresses assisted reproduction and post mortem artificial insemination. 

MY ADVICE ABOUT GZERO DATA & UN DEVELOPMENT PROGRAM: Do not let numbers alone shape your conclusions; numbers often miss subtleties. Even where quantification seems favorable to women, girls and other groups: Are the governments democratic? What is the social and economic class of the women in government? What interests do they represent? Are they confined to committees dealing with what men derisively call "women's issues"? Do women hold executive authority? Is rubber-stamping executive wishes parliament's key function? How does the country deal with ethnic, racial, LGBT, religious, and other groups? Even where laws protecting human rights exist, are those laws enforced? Are these laws and their enforcement dispensations from the top or the hard-earned fruit of grass root efforts? Numbers can mask these and other complexities.

Most sources in this bibliography come from websites; hence, citing in group papers and interpretative essays the publications this bibliography compiles is subject to the TEN-POINTS-OFF policy explained on pg. 6 of the syllabus.
