Log Data

In our previous trail we created a TypeScript file with the Mock data inside an Array. But doing it this way does not allow us to have a real data serice or simulate any BE call, moreover we are not providing any specific endpoints configuration, request and response type, etc.

Generating the data service from the RAML file is solving all those problems. If we enable Mocks in our Web Browser we can now see console logs containing all the informations about the mocked request, so when the time has come to integrate with a real BE it will only be required to disable the Mocks in the Web Browser to see the request happening with the right configuration.
