THE ME & LAU FAMILY FOUNDATION SCHOLARSHIP

PURPOSE

The purpose of the ME & Lau Family Foundation ("ME" hereafter) Scholarship is to encourage and promote the attainment of higher education goals for individuals with a proven financial need in York Region. Consideration will be given to students who have demonstrated a high level of academic achievement, who have made a positive contribution to people with intellectual disabilities through involvement in extracurricular activities, and who have made significant contributions of time and energy to community services programs.

DESCRIPTION

The Scholarship will be \$1,200 (in Canadian Dollars) to a student pursuing education in a postsecondary institution who is selected by ME & Lau Family Foundation's Awards/Scholarships Committee. The funder reserves the right to interview each candidate prior to making a final decision. The Scholarship is aimed to be used towards post-secondary education expenses such as tuition, books, supplies, and other related expenses. The Scholarship is awarded only in the student's first year at a post-secondary institution and as such applications are limited to one per candidate.

ELIGIBILITY

Applicants must meet all of the following criteria:

Residency

- Be a student currently in their final year of high school within York Region, and will be attending a postsecondary institution in the fall to pursue a minimum of 2 years of full-time study leading to a degree or diploma, in a public college or university within Canada.
- Successfully obtain and provide a copy of their Ontario Secondary School Diploma (OSSD) within York Region.

or

• A post-secondary student studying at any post-secondary institution, that ordinarily has ties with York Region. Ties may include familial ties, or other personal ties such as a history of living within York Region.

Income

• Provide supporting documentation of family income threshold of \$140,000 or below. In the case where no parental support is provided to the student a copy of the Family Breakdown application submitted to OSAP.

Extra-curricular Involvements

• Have made a positive contribution to people with intellectual disabilities.

SCHOLARSHIP SELECTION REQUIREMENTS

In addition to the candidate's academic abilities, the Awards/Scholarships Committee will evaluate the candidate's positive contribution to people with intellectual disabilities in the community. Contributions to the community may be demonstrated by involvement in local clubs, activities, and organizations such as Community Living York South, Community Living Ontario, ME & Lau Family Foundation etc. Based on the statistical analysisⁱ, candidate with household income of \$140,000 or below in York Region may be benefited from some financial assistance in form of scholarship.

FUNDING AND PAYMENTS

All payments will be made directly to the Scholarship recipient. The recipient must provide satisfactory proof of enrollment and official timetable. Funds will be released after the withdrawal date of the recipient's postsecondary institution. Under the direction of the Awards/Scholarships Committee, Community Living York South will provide a cheque to the recipient. The donor will provide the \$1,200 annual scholarship fund to Community Living York South by April 1 of each year until this scholarship ceases to operate.
