ESSENTIAL QUESTIONS

- What does the Constitution say about voting rights? What's in there, and what isn't? Who can vote in America (and when)?
- Before the Constitution, who could vote, and which level of government controlled the vote? (Federalism)
- How did Reconstruction transform voting rights in America? What were its limits?

BIG TAKEAWAYS

• The Original Constitution left voting issues largely to the states. It's a story of federalism/state power. Several amendments extend protections to new groups, including protections based on race (Fifteenth Amendment), gender (Nineteenth Amendment), and age (Twenty-Sixth Amendment). While the states still play a central role in elections, various amendments establish an increased role for the national government in some contexts—most notably, through the enforcement clauses of the Fifteenth, Nineteenth, Twenty-Fourth, and Twenty-Sixth Amendments. (This is still a federalism story.)
