# **Cuddledot's Art and Commissions Terms of Service**

You must agree to the terms of conditions, my boundaries and rights as an artist, and the rights of the commissioner. Please read these terms and conditions below. Commission prices and examples can be viewed here. I have the right to refuse any commission that makes me uncomfortable for any reason.

#### What I Can Draw

#### The list below is what I can draw upon the client's request:

- Furry and anthropomorphic characters. Human characters, fantasy creatures, robots, toons, or any other nonhuman characters.
- Ocs, Fan characters, and Sonas.
- Gijinka designs
- Gore art, Candy Gore, and Body Horror.
- Environmental scenes and backgrounds
- Commissioner portrait (request on drawing the commissioner themselves or someone else.) I get wary of drawing IRL people in a commission unless it's for a gift art of said real-life person or it's consented to. However, I will not draw NSFW or any hateful subject on said real person.
- Pets and animals of the commissioner's request.
- Suggestive content and artistic nudity
- Simple Mecha
- NSFW Art (18+ clients only!!)
- Self-ship art/OC x Canon

#### What I WON'T Draw

#### The list below is what I refuse to draw:

- Incest, racist, pedophilic, homophobic, and transphobic undertones.
- Illegal NSFW content (if unsure, ask)
- Hate/bigoted art or any sort targeting a marginalized group
- Very complex mecha
- Extreme Gore/Snuff
- Questionable Media or content I may be uncomfortable with (feel free to ask questions on DMS or email)

## **Regards to Mature Orientated Content**

For adult-orientated commission pieces (NSFW, pinups, etc) <u>are only for clients 18+ and older.</u> Underaged clients lying about their age just to receive 18+ content will result in a block and blacklist on future commissions. Pricing of said 18+ Commissions is different from SFW Commission pricing, due to factors like complexity poses, anatomy, and erotic themes.

# There are limits to illustrating these artworks. I will not accept requests or draw any illegal content. Which includes:

- NSFW, suggestive, and extreme gore art of underage characters, zoo content, or any illegal situations
- Aging up characters solely for NSFW
- Content-based on a real-life person

## **Commission Request Methods**

There are different methods to reach out to me. The following options are:

#### **Commission Google Application Form**

- There is a <u>Google form</u> for clients to apply and fill out with the required questions for the application.
- Easier to keep track, and you can put all the information of your commission request in one, along with putting in your preferred method of communication, image references, etc
- Once completing the form, I will reach out to you with your desired method of contact listed on the form.

#### **Ko-Fi Commission Requests**

 I take commissions on Ko-Fi as well with the list of required commission types. Slots are limited to prevent high traffic of clients. There are also special Ko-Fi commissions for members only and the highest tier allows for discounts. I will not take NSFW requests on Ko-Fi.

#### **Direct E-mail**

Note: When providing references, send as many visual refs and verbal descriptions as possible. It doesn't have to be like a novel-length, just at least brief! **AI Art for referencing does not count!!** 

## **Payment and Art Process**

I take payments upfront after confirmation. The art process time highly depends on the number of clients in the queue and the type of commission. After accepting the payment, updates will be provided frequently for each process (e.g. sketch, line art, color, posing, composition)

#### **Payment Options**

- The main payment options are PayPal and Stripe and always use invoices for both. Invoices will be sent once the commission reaches an agreement.
- I won't be accepting checks or cryptocurrency as a form of payment.

#### **Termination Policy**

- Clients will receive a full refund on the commission ONLY during the sketching phase of it.
- Anything after the sketching phase (line art, color, etc) the client will receive a partial refund.
- After the commission is finished, no refunds will be issued.

## Ownership Usage and Rights

You have the rights of ownership of the piece given to you, **but not the copyright or claim of creation of the piece**. As the artist, I have the right to display the commission piece on my social platforms to showcase my services and art-related events promotions, and for sites like Patreon and Ko-fi for unwatermarked high-quality pieces and/or early art access for exclusive members. If you don't want your piece to be displayed online and/or behind paywalls on Patreon and Ko-fi, do let me know otherwise.

#### **❖** You're free to use the commission piece for noncommercial purposes such as:

- > Self-promotion and platform building on social media like podcasts, streaming, content creation, etc
- > Profile pictures and banners
- > Display requested characters for references, etc.
- > Educational and presentational purposes
- > Credit on the commission piece is highly appreciated!

# There are prohibitions you're NOT allowed to do with the given commission piece(s), and those prohibitions are:

- ➤ Using my art for NFTs and AI. This includes using the AI to 'finish' or edit the pieces, any AI-related training, and alterations.
- > Editing or tampering with my art with offensive imagery.
- ➤ Reselling my work (e.g. prints, clothing, stickers) and reposting without permission and claiming it as your own.
