

## Privacy Policy

We pay attention to your privacy, so we sincerely wish you to understand what information we collect, and how we use and share it. By downloading the App or using any of our Service, you will be deemed to have consented to our collection, storage, use and disclosure of your personal information as described in this Privacy Policy. If you are not agreed with this Privacy Policy you should not use our App or our Service. This Privacy Policy applies only to information collected through this App, and for information provided offline. If the user links to outside websites or other App, please review their posted Privacy Policies.

### PART1: CHILDREN PROTECTION

We do not intentionally collect personal information of persons under 13 years old (in EEA is under the age of 16). If you are under 13 years old please do not send us your personal information (for example, your name, address and email address). If you are under 13 years old, you want to use this App which requires you to submit your personal information, please get your parent or guardian to do so on your behalf.

### PART 2: TYPES OF INFORMATION COLLECTED

When you use the App, we may collect your information including but not limited to:

1. User IDs (such as account ID, password, etc.);
2. Name (such as first or last name, or nickname);
3. Contact information (such as date of birth, cell phone number, email address, gender identity, etc.);
4. Web browsing history;
5. Device information (such as type, model, version, brand, language and resolution etc.);
6. Approximate location;
7. App activity (such as page views,click-through statistics, app interactions, other user activity or actions in-app, etc.)
8. Network information (such as type,operator etc.);
9. App information and performance (such as Crash logs, Diagnostics,etc.);
10. Operating system information (such as type, version name and version number);
11. Identifiers that relate to an individual device, browser or app (such as advertising id,UUID etc.);
12. If you register through your Facebook credentials, we may collect some personal data through your Facebook account;

If you need to utilize all functions of the App, including without limitation, receiving payments (if any), it may be necessary to provide the personal information. However, if you refuse to provide any personal information, it may be possible for you to only use portions of the App.

### PART 3: HOW WE USE THE INFORMATION WE COLLECT

**AT NO TIME WILL WE RENT, TRADE OR SELL YOUR INFORMATION!**

We use the information for statistical purposes, and not in a manner that would give us sufficient data to identify you personally. For instance:

- 1.To provide you with our Services;
- 2.To confirm your identity, contact you, provide you with advertising;
- 3.To help us better understand how users are using this application;
- 4.To make changes to the App that allows users to have better experiences and improve the App, our offers and promotional content so that they are more relevant to you;

5. For security, system integrity (the prevention of hacking, cheating and other improper or unlawful activities), or enforcement purposes;
6. To make sure that we comply with applicable legal requirements.

#### PART 4: WHOM WE MAY SHARE THE INFORMATION

If you provide us with personal identifiable information, we may share necessary information with other affiliate companies, so as to serve you in the most effective and efficient way unless such sharing is prohibited by related laws or regulations.

We work with a variety of third parties and service providers such as third party subcontractors, affiliates of us, retailers, fulfillment partners and marketing partner to help provide you with our Services and we may share information with them to support these efforts. For example, companies we've hired to provide information analytic services may need to collect and access personal information to provide those functions. In such cases, these companies must abide by our data privacy and security requirements, and follow Apple's Privacy rules.

#### PART 5: YOUR RIGHTS

You have rights to restrict us to collect and use your personal information, which may include the rights:

1. To update and correct your personal information;
2. To request access to and a copy of your personal information;
3. To restrict or object to collection and using of your personal information;
4. To withdraw your consent at any time. The withdrawal of consent shall not affect the lawfulness of processing based on consent before its withdrawal;
5. To request erasure of your personal information;

If you want to exercise any of your rights, please contact us. We may ask you to verify your identity, and act upon your requests in accordance with applicable laws. We aim to respond to your request within 45 days of receiving that request. If we require more time, we will inform you of the reason and extension period in writing.

#### PART 6: HOW WE PROTECT THE INFORMATION

We take reasonable measures to help protect your information from loss, theft, misuse and unauthorized access, disclosure, alteration and destruction. We use industry-standard physical, procedural and electronic security measures, including encryption where deemed appropriate in order to protect your personal information held with us and third parties we work with. However, no method of transmission over the Internet, or method of electronic storage, is 100% secure. Therefore, we cannot guarantee its absolute security.

#### PART 7: HOW LONG DO WE RETAIN THE INFORMATION

We keep your personal information as long as we need it to provide our App comply with legal obligations or protect our or other's interests. We decide how long we need information on a case-by-case basis. Here's what we consider when we decide:

1. To operate or provide our App. For example, we need to keep some of your personal information to maintain your account.
2. The feature we use it for, and how that feature works. For example, messages sent using Messenger's vanish mode are retained for less time than regular messages.
3. To comply with certain legal obligations.

4. For other legitimate purposes, such as to prevent harm; investigate possible violations of our terms or policies; promote safety, security and integrity; or protect ourselves, including our rights, property or products.

In some instances and for specific reasons, we'll keep information for an extended period of time.

#### PART 8: SPECIAL PROVISION

When you are located in the European Economic Area (EEA), you can (i) ask for a copy of your personal information to be provided to a third party; (ii) lodge a complaint about the processing of your personal information with your local data protection authority in the EEA. You hereby consent to the transfer of your personal information to recipients, as described in this Privacy Policy, which are located outside the EEA. You may withdraw your consent at any time.

When you are located in the EEA, your personal data will be transferred to recipients in countries located outside the EEA, which do not provide a similar or adequate level of protection to that provided by countries in the EEA.

#### Part 9: UPDATE TO PRIVACY

We may update this Privacy Policy from time to time in order to reflect, for example, changes to our privacy practices or for other operational, legal, or regulatory reasons. If we make material changes to this Privacy Policy, we will give you notice of such changes by posting the revised policy on the App or our website, and where appropriate, by other means. By continuing to use the Service or our website, after these changes are posted, you agree to the revised policy.
