Since December 2015, our company has been acting as a customs broker at the customs office of "DHL" LLC in Zamiin-Uud...

- From April 2016 to August 2019, operations are being carried out in the customs control zone of the "Ovoot Tolgoi" coal mine of "Southgobi Sands" LLC located in the Gurvantes sum area of Umnogobi province.
- Since March 2018, the transshipment terminal of "E-Trans Logistics" LLC in Zamiin-Uud has been operating until now.
- In 2018-2019, it is operating in the "Cargo Terminal" customs control area of the customs office in Buyant-Ukhaa.
- In 2019, operations are being carried out in the customs control zone of the "Bayan Tes" coal mine of the "South Gobi Coal Trans" LLC, located in the Gurvantes sum area of the Umnogobi province.
- From January to July 2019, we are operating in the "Interdecision" customs control area under the customs office in Ulaanbaatar.
- From July to December 2020, operations are being carried out in the customs control zone in Tsagaan Khad, located in the Hanbogd Sum area of Umnogobi Province.
- From July to November 2021, the cargo terminal at Genghis Khan International Airport is operating.

It has been operating at the customs office in Ulaanbaatar since June 2021.

In 2022, with the goal of increasing business activities and increasing employment, it is planned to establish an "Independent Customs Information Center" to increase work productivity with the Ulaanbaatar Customs Department.
