REPORT

Regarding amendments to some of the Company's business lines

(Replacing Report No. 1641/TTr-VNPD dated November 7, 2023)

To: General Meeting of Shareholders of Vietnam Power Development Joint Stock Company

- Pursuant to Enterprise Law No. 59/2020/QH14 dated June 17, 2020;
- Pursuant to Securities Law No. 54/2019/QH14 dated November 26, 2019;
- Pursuant to Investment Law No. 61/2020/QH14 dated June 17, 2020;
- -Pursuant to Decree No. 155/2020/ND-CP dated December 31, 2020 detailing the Securities Law 2019:
- Pursuant to Decree No. 31/2021/ND-CP dated March 26, 2021 detailing and guiding the implementation of a number of articles of the Investment Law;
- Pursuant to Vietnam's specific commitments on WTO accession; Comprehensive and Progressive Agreement for Trans-Pacific Partnership (CPTPP); Free Trade Agreements (FTAs); ASEAN Framework Agreement on Services (AFAS); Vietnam Korea Free Trade Agreement (VKFTA); Vietnam EU Free Trade Agreement (EVFTA); National Information Portal on Foreign Investment (FIA Vietnam) under the Foreign Investment Department Ministry of Planning and Investment;
- Pursuant to the Charter of Vietnam Power Development Joint Stock Company amended and supplemented according to the Resolution of the 2023 Annual General Meeting of Shareholders;
- Pursuant to the internal regulations on governance of Vietnam Power Development Joint Stock Company amended and supplemented according to the Resolution of the 2023 Annual General Meeting of Shareholders;
- Pursuant to Board of Directors Resolution No. 1497/NQ-HĐQT dated October 10, 2023 on organizing the extraordinary General Meeting of Shareholders in 2023.

Vietnam Power Development Joint Stock Company (Company) was granted the first Business Registration Certificate by the Hanoi Department of Planning and Investment No. 0103001110 on June 3, 2002, registered for 15th change number 0101264520 dated May 4, 2023. After 21 years of operation and development, up to

now, a number of the Company's registered business lines need to be amended and supplemented to suit the operating situation and general development trend of the country and at the same time ensure the determination of the maximum foreign ownership ratio according to current law provisions. Therefore, the Board of Directors of the Company respectfully submits to the General Meeting of Shareholders to consider amending the list of registered business lines of the Company with the following contents:

I. REASON FOR PRESENTATION

Among the Company's actual business lines, there are currently many registered investment and business codes in the List of industries and trades with limited market access for foreign investors/ List of industries. conditional market access occupations for foreign investors in Appendix I of Decree No. 31/2021/ND-CP/ List of goods and services subject to state monopoly in regulated commercial activities stipulated in Decree 94/2017/ND-CP. Accordingly, the maximum foreign ownership ratio (determined by current business lines) of these industry codes is 0%. This limits foreign capital investment in the Company. To attract foreign investment capital while ensuring the rights and benefits of existing shareholders who are foreign investors, the Company revised the details of a number of the Company's business lines.

The company is stably operating 03 hydropower plants (Khe Bo Hydropower Plant, Bac Binh Hydropower Plant and Nam Ma Hydropower Plant) with a total capacity of 136.2MW. One of the most important strategic goals of the Company at the present time is to research, seek and invest in new feasible projects with the aim of expanding the scale and development of the Company in the future. This development plan was approved by the General Meeting of Shareholders in resolution No. 657/NQ-DHĐCD dated April 25, 2023 and approved by the Board of Directors in decision 690/QD-VNPD dated April 28, 2023.

From the above analysis, the Board of Directors submits to the General Meeting of Shareholders for approval detailed amendments to a number of the Company's business lines as necessary, in accordance with the law and in accordance with development needs of the Company now and in the future.

II. BROWSER CONTENT

1. Amending a number of professions in the Company's registered business lines, specifically as follows:

- 2. Based on the expected business lines after the amendment as presented in part 1 above and the actual current business activities as well as the Company's development orientation, the Board of Directors respectfully submits to the General Meeting of Shareholders through changing the posting of main business lines in the list of registered investment and business lines, specifically as follows:
 - Unregister industry code (3512 (Main)) Electricity transmission and distribution (Details: Electricity distribution and sale) is the main business line of the Company.
 - Register industry code: (3511) Electricity production (Details: Electricity production (except construction and operation of multi-purpose hydropower plants, nuclear power of special socio-economic importance)) is Main business lines of the Company.
- 3. The Board of Directors respectfully submits to the General Meeting of Shareholders to approve the amendment of Clause 1, Article 4 of the

Company's Charter according to the list of registered investment and business lines after the amendment as presented in Part 1 above.

III. General Meeting of Shareholders:

1. Assign the Legal Representative to direct the implementation of procedures to change the Company's investment and business lines with the competent authority according to the changes stated in Section II of this Proposal.

2. Assign the Board of Directors to proactively decide on all issues related to the addition and modification of detailed industries and professions within the scope of business lines approved by the General Meeting of Shareholders and the above amendments at the request of the shareholders. Competent State agencies (if any) to ensure compliance with the law and the highest interests of the Company. Amendments and supplements will be reported to the General Meeting of Shareholders by the Board of Directors at the nearest meeting.
