The EWC25 LEV Superfan Program

Terms and Conditions for Club LEVIATÁN Superfan Selection

Club LEVIATÁN, with its registered office located at Buenos Aires, Argentina (hereinafter "Club") is hereby offering its fans the chance to win a free trip to the 2025 Esport World Cup in Riyadh, Saudi Arabia. The selected fan will enjoy an amazing week exploring the EWC25 festival, the urban wonders of Riyadh and the unique heritage and welcoming culture of Saudi Arabia.

Participation in the application process is free of charge, not linked to the purchase of goods or services and subject to the following terms and conditions (hereinafter "T&Cs"). This promotional initiative is not associated with the purchase of any goods or services and constitutes a free prize giveaway under promotional terms:

1. Participation is open exclusively to natural persons who, at the time of submission, are at least 18 years of age and have their permanent residence [outside of the GCC region and are not GCC nationals] (hereafter "Participant"). Employees, freelancers, coaches and players and third-party service providers of the Club or any employees or freelancers or EWCF, as well as their partners and relatives, are not eligible to participate.

By applying, the Participant expressly consents to the Club verifying their identity, age and permanent residency status at any stage of the process.

- 2. By participating on the different activations, the Participant agrees to the applicability of these T&Cs. Only one application per activation is permitted. Multiple applications or submission of false information will result in disqualification from the selection process. The Club reserves the right to verify the accuracy of all information provided and to request additional documentation at its sole discretion. Participating does not create any legal claim or entitlement to be selected for the EWC25 Club Superfan Program.
- 3. Participants must have a passport that is valid for at least 6 months after the time of travel or meets reciprocity rules.
- 4. The participant must be approved by the Saudi government to obtain a visa. If denied, the Club has the power to revoke the package and select another participant. The Participant expressly waives any claim against the Club in the event the visa is denied or revoked by the Saudi authorities
- 5. After the end of the application period, Club will select a limited number of Participants to be eligible for the EWC25 Superfan Package Services (as defined below) and notify them via email (selected Participants hereafter "Club Superfans").
- 6. Participants must confirm acceptance of their selection as Club Superfans via email within two (2) calendar days of receiving the notification email. If Club does not receive a confirmation email within this period, Participant's entitlement to the EWC25 Superfan Package Services shall be forfeited without substitution and Club may select another Club Superfan. Failure to confirm within the established deadline shall be deemed a waiver of participation rights and no further obligation shall be imposed on the Club. A binding agreement between the Club Superfans and the Club is established only upon receipt of such acceptance email sent by the Club Superfan.

- 7. The selection of the Club Superfans is at the sole discretion of the Club based on the criteria set out on the Club's website and not subject to appeal. Participants shall have no right to challenge or contest Club's decision through legal proceedings and Club is under no obligation to disclose the specific reasons that lead to its decision. Participants hereby irrevocably waive any right to challenge or contest the Club's decision in any legal or administrative forum.
- 8. The ClubSuperfans shall be entitled to receive cost coverage by Club, e.g. in the form of vouchers, solely for the following third-party services (hereinafter "EWC25 Superfan Package Services"):
 - A two-way flight to Riyadh from a departure airport designated on the Club's website in economy class;
 - One EWC25 Weekly Ticket (access the EWC festival and to all games and from Thursday to Sunday with regular seating during the week specified on the Club's website);
 - Five nights' accommodation in a 3- to 4-star hotel in Riyadh selected by Club (check-in on Wednesday, check-out on Monday during the weeks specified on the Club's website);

The Club shall not be held responsible for delays, cancellations or failures in the provision of services by third-party vendors.

- 9. The EWC25 Superfan Package Services are strictly limited to the travel dates and departure/arrival locations specified on the Club's website and subject to Club Superfan being granted a tourist visa for the Kingdom of Saudi Arabia, with the costs for an application service also borne by Club. However, no cost coverage for any changes, substitutions or alternatives are offered and Club will not cover any costs beyond for the services expressly listed in Section 7 of these T&Cs or for any EWC25 Superfan Package Services that Club Superfan has booked itself without consulting the Club in advance.
- 10. The agreement between the Club Superfan and the Club is not transferable by Club Superfan and limited to the coverage of costs for the EWC25 Superfan Package Services, e.g. in the form of vouchers. Club does not offer any travel services of its own, nor does it act as a tour operator. The EWC25 Superfan Package Services are not redeemable for cash and cannot be exchanged for any other benefits or services. The Club shall be entitled to engage third parties for the performance of its obligations without requiring prior consent from Club Superfan. Club Superfan agrees that such engagement shall not establish any contractual relationship between those third parties and Club Superfan.
- 11. The Club reserves the right to reassign the EWC25 Superfan Package Services to another Participant if the originally designated Club Superfan, despite being duly notified via email, fails to provide the required data or documentation necessary for the delivery of the EWC25 Superfan Package Services, or fails to carry out the required acts of cooperation with third-party service providers within the communicated deadlines (e.g., flight or hotel bookings, submission of passport information, etc.). The same applies, if the Club Superfan is denied a tourist visa to the Kingdom of Saudi Arabia or if such visa is revoked

- 12. Any personal data collected in connection with the EWC25 Superfan Package Services will be used exclusively for the purpose of selecting the Club Superfans and providing the EWC25 Superfan Package Services. By accepting the selection, the Club Superfan consents to the transfer of their personal data to third parties (e.g., airline, hotel, EWC event organizer) solely for the purpose of and only as far as required for facilitating cost coverage and organization and provision of the EWC25 Superfan Package Services.
- 13. By submitting the confirmation email, the Club Superfan consents to the publication of its name and/or a selected social media alias on the Club's website and official social media channels for the purpose of announcing the selected Club Superfan. This consent may be withdrawn at any time with future effect by notifying the Club via email.
- 14. Club LEVIATÁN Superfan hereby grants to Club a perpetual, irrevocable, exclusive, royalty-free, transferable (including the right to grant sub-licences), worldwide license to reproduce, make available or otherwise use any and all rights in and to (i) the content created by the Participant as a condition for application in accordance with the criteria on the Club's website and submitted as part of the application ("UGC") and (ii) any content that Club may create with involvement or participation of Club Superfan on site at the EWC ("EWC Club Content"), in particular by way of making the UGC and/or EWC Club Content available to the public on any social media channels or other platforms.
- 15. Club reserves the right to terminate the Club Superfan selection at any time for good cause or to amend these T&Cs, provided that such changes are necessary and do not unreasonably disadvantage the Participants.
- 16. To the fullest extent permitted by applicable law, the Club, its partners, directors, officers, legal representatives, employees, contractors, agents, and affiliates shall not be liable under any circumstances for any kind of damages or losses, whether direct, indirect, incidental, special, consequential, punitive or otherwise, including but not limited to damages for personal injury, death, loss of profits, business interruption, loss of data, loss of reputation, or any other loss or damage, whether arising in contract, tort (including negligence—whether ordinary or gross), strict liability or otherwise.

The User expressly waives any and all claims or causes of action against the Club and/or any of its partners, directors, officers, legal representatives, employees, contractors or agents for any kind of damages, except where a specific liability cannot be excluded under mandatory applicable law.

This limitation and exclusion of liability applies even if the Club has been advised of the possibility of such damages, and shall extend in full to all of the Club's representatives, including, without limitation, its legal representatives and agents.

- 17. These T&Cs shall be governed by and construed in accordance with the laws of [Los Angeles California].
- 18. Should individual provisions of these Terms and Conditions be or become invalid or unenforceable, the validity of the remaining provisions shall remain unaffected. The invalid or unenforceable provision shall be replaced by a valid provision which, to the extent legally permissible, most closely reflects the economic intent and purpose of the original provision. The same shall apply in the event of an omission.
- 19. Winning any of the activations or thematics through the different platforms of the Club, does not guarantee the election and delivery of the prize. This is due to the fact that the participant must comply with all the requirements stipulated in this Term & Conditions or subsequent requirements communicated by the Club via email.
