- Written nominations for election shall be received by the Chairman not less than 14
 working days before the date of the Annual General Meeting at which the elections are
 to be held.
- Candidates must be members of OANZ and be nominated and seconded by a member and be accompanied by the written consent of the nominee.
- Not less than seven working days before the date of the Meeting, the list of candidates and such information (not exceeding one side of an A4 sheet of paper) as may be supplied to the Chairman by each candidate in support of their nomination shall be emailed to all Members.
