The data collected through Google Analytics helps us understand usage patterns and improve our services. This data is aggregated and anonymized to protect your privacy.

We do not sell, trade, or otherwise transfer your Personally Identifiable Information to outside parties unless we provide you with advance notice or are required by law. However, **Classic Big Keyboard** may share non-personally identifiable visitor information with trusted third parties for the purposes of analytics, marketing, or similar uses.

Keyboard Permissions

To provide the best user experience, **Classic Big Keyboard** may require access to specific device permissions, such as:

- Access to the keyboard service for text input,
- Optional microphone access for voice typing features (if enabled).

processed securely through the Google In-App Billing library managed by Google. You are not obligated to make any purchase to use **Classic Big Keyboard**.
