ELIGIBILITY:

All players must be a resident of Arkansas and a member of the USATT (except for non-sanctioned events listed above). Military personnel stationed in Arkansas and full time students attending school in the state are eligible.

TOURNAMENT RULES:

- OPEN A-B-C-D ROUND ROBIN: Limited to the first 32 entries; open to all players. Groups of 3-5 players; all players advance to second round robin. Winners advance to Open Singles; second place to A Singles, etc. Format after the second round robin determined by number of entries.
- ALL OTHER ROUND ROBIN EVENTS: Each group will consist of at least 3 players, maybe more. The second round format (if required) will be determined by the number of entries and number of tables available.
- OPEN & U3400 DOUBLES: Players have until 11am to find a partner. Maximum of 6 teams in Open doubles; maximum of 9 teams in U3400 doubles. Both events round robin groups of three – second round format determined by number of entries.
- EQUIPMENT: Stiga/Donic tables; Stiga and Tibhar nets; Nittaku poly white 3 star premium 40 mm balls; wood flooring.
- RATING EVENTS: limited to the first 6 entries – might be expanded if tables & time permit
- JUNIOR/WOMENS/AGE SINGLES: Limited to the first 4 entries; field may be expanded if time permits. Juniors must be 17 or younger on 10-11-25.
- All USATT rules apply. Rackets must meet USATT regulations.
- Events with less than 3 entries may be cancelled or combined with the next higher rated event.
- All matches are best 3 out of 5 games - games to 11.
- Unrated players must have the approval of the tournament director before entering rated events.
- All players must report to the control desk 20 minutes prior to the start time of their first event.
- No lunch provided so plan accordingly. Forfeits will be called if players have left the tournament site without permission of the Tournament Director or Control Desk.
- No refunds the day of the tournament, except in doubles if a partner cannot be found.
- The rating posted on the USATT website as of the 10-05-25 will be a participant's rating.
- A player may not enter 2 or more events that start at the same time.
- Matches must be played for prize money to be awarded. Splitting of prize money is not allowed.

Three ways to pay

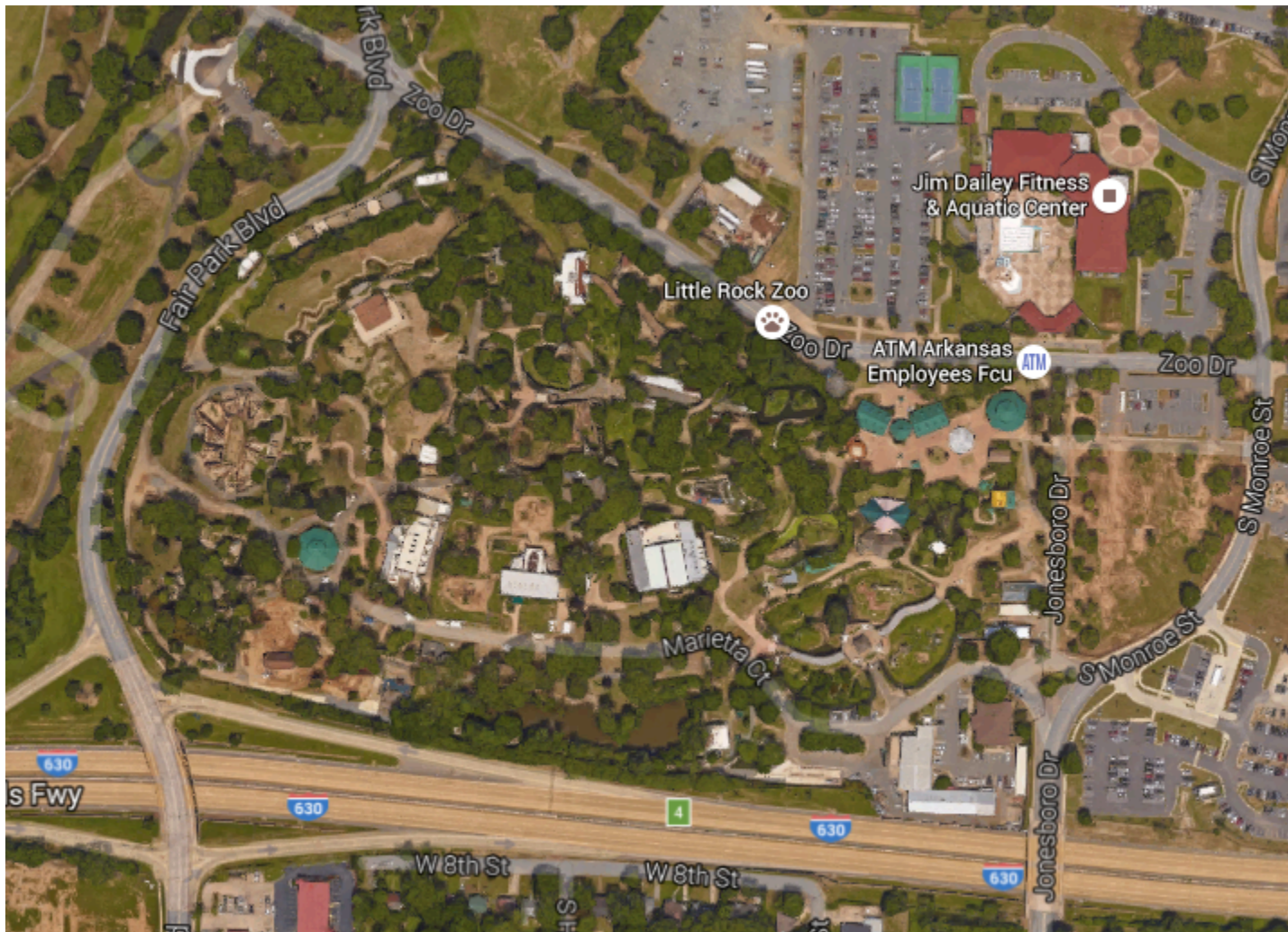
1. Mail cash/money order to above address. Online fee would not apply.

USATT COACHING POLICY All persons who are engaged in coaching activities at USATT Affiliated Member Clubs and/or USATT Sanctioned Tournaments, except parents or legal guardians coaching their own children, must be Fully Safe Sport Compliant, which requires completing SafeSport Training offered by the US Center for SafeSport every year and undergoing a criminal background screen every two years. ADULT PARTICIPANTS REQUIRING SAFESPORT TRAINING Pursuant to USATT's Minor Athlete Abuse Prevention Policy, ALL Adult Participants (participants over the age of 18) who have regular contact with or authority over minor aged athletes must complete SafeSport Training offered by the US Center for SafeSport every year ("SafeSport Trained"). CONTACT USATT TO BECOME SAFESPORT TRAINED AND/OR FULLY SAFE SPORT COMPLIANT USATT is pleased to assist USATT Members in the process of becoming SafeSport Trained and/or Fully Safe Sport Compliant. MANDATORY REPORTING There are certain circumstances where reporting a potential Safe Sport violation is mandatory. These circumstances include: (i) child abuse; (ii) sexual misconduct; (iii) emotional and physical misconduct; (iv) criminal charges and/or dispositions involving sexual misconduct or misconduct involving minors; (v) any abuse of the Safe Sport process. Child abuse must be immediately reported to local law enforcement. 1. IN CONSIDERATION of being permitted to participate in any way in USA Table Tennis sanctioned events, I and/or my minor child, our personal representatives, assigns, heirs, and next of kin:

ACKNOWLEDGE, agree, and represent that I and/or my minor understand the nature of Table Tennis Activities and that I and/or my minor child are qualified, in good health, and in proper physical condition to participate in such Activity. I further agree that if at any time I believe conditions or equipment to be unsafe, I and/or my minor child will immediately discontinue further participation in the Activity.

3. FULLY UNDERSTAND that (a) TABLE TENNIS ACTIVITIES INVOLVE RISKS AND DANGERS OF SERIOUS BODILY INJURY, INCLUDING PERMANENT DISABILITY, PARALYSIS AND DEATH, HARASSMENT, EXPOSURE TO INAPPROPRIATE CONDUCT AND LANGUAGE ("RISKS"); (b) these Risks and dangers may be caused by me and/or my child's own actions, or inaction, or the actions or inaction of others participating in the Activity, the condition in which the Activity takes place, or THE NEGLIGENCE OF THE "RELEASEES" NAMED BELOW; (c) there may be OTHER RISKS AND SEVERE SOCIAL AND ECONOMIC LOSSES either not known to me or not readily foreseeable at this time; and I FULLY ACCEPT AND ASSUME ALL SUCH RISKS AND ALL RESPONSIBILITY FOR LOSSES, COSTS, AND DAMAGES I and/or my minor child incur as a result of my participation in the Activity.

4. HEREBY ACCEPT AND ASSUME ALL SUCH RISKS, KNOWN AND UNKNOWN, AND ASSUME ALL RESPONSIBILITY FOR THE LOSSES, COSTS, AND/OR DAMAGES FOLLOWING SUCH INJURY, DISABILITY, PARALYSIS, OR DEATH, EVEN IF CAUSED, IN WHOLE OR IN PART, BY THE NEGLIGENCE OF THE "RELEASEES" NAMED BELOW;

5. HEREBY RELEASE, DISCHARGE, AND COVENANT NOT TO SUE USA TABLE TENNIS, their respective administrators, directors, agents, officers, officials, volunteers, and employees, other participants, any sponsors, advertisers, and if applicable, owners and lessors of premises on which the Activity takes place, (each considered one of the "RELEASEES" herein) FROM ALL LIABILITY, CLAIMS, DEMANDS, LOSSES, OR DAMAGES ON MY ACCOUNT CAUSED OR ALLEGED TO BE CAUSED IN WHOLE OR IN PART BY THE NEGLIGENCE OF THE "RELEASEES" OR OTHERWISE, INCLUDING NEGLIGENT RESCUE OPERATIONS; AND I FURTHER AGREE that if, despite this RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK, AND INDEMNITY AGREEMENT I and/or my minor child, or anyone on my and/or my minor child's behalf, makes a claim against any of the Releases, I WILL INDEMNIFY, SAVE, AND HOLD HARMLESS EACH OF THE RELEASEES from any litigation expenses, attorney fees, loss, liability, damage, or cost which may incur as the result of such claim.
