- Proposal #1 - Zuri Aki: Community Councils
  - Ho'olauna & Mahalo for the opportunity to share this proposal
    - From Waipi'o, O'ahu
    - Policy Manager at CNHA
  - Community Councils
    - A really pumped up neighborhood board that can really shape committee and not just a board to hear concerns
    - Idea specifically for the Native Hawaiian community
      - Free prior and informed consent
      - Having issues heard and real change
    - Operate like a mini City Council
    - Not a new idea because this is something that Native Hawaiian communities have been doing forever
    - We really excel on the community, grassroots level
    - Civic engagement
      - Many of us in neighborhood boards, 'Aha Moku, community members engaged in resource management
      - We get jammed up in the higher rungs of government and no real capacity to get elected
      - But in the neighborhood level, we really excel

- A legacy governance structure from our ancestors
- What would an ideal Hawai'i look like?
  - Community council that is the first line and key decision making bodies
- Q&A
  - What makes this different than existing organizational structures?
    - Z: actual decision making authority
  - Nālani Minton: Kumu John Ka'imikaua and the 'Aha Kiole on Moloka'i and a value that we can use. As an example in health profession, when a community is organized to support the 'āina and life, the whole country (made up of every single community) worked together to stop the spread of COVID-19
  - Maui Mayor: No neighborhood boards on Maui but there are community associations. We tried to go to the Council to get it institutionalized and there was real reluctance to support. Possibly hesitant because it may erode their power. Would love to establish something like this on Maui
  - Miwa: we need decision-making authority and not just advisory
  - Sam: who and how is a community defined?
    - Z: on O'ahu we have defined communities in the neighborhood boards but it isn't necessarily how we identify and group ourselves; did a picture of a traditional ahupua'a in Central O'ahu and how a Community Council could work (Waipi'o, Waikele, etc.); 'āina-based and people-based model that will require communities to talk it out
    - Mehana: like Z mentioned, communities define themselves
  - Kawika: is there something that you are still trying to figure out?
    - Z: community-based struggle; we have a large transient population here in Hawai'i; this population can easily overrule communities by sheer amount and size; how do we get the "rooted folks" to still have a say?; but the thought is for this to be a Native Hawaiian council that serves alongside any other bodies; a "barrier" to certain things being passed through communities, like TMT; if we had a Community Council, things would be different; how do we truly empower the community?
  - Lala: I'm interested in taking this model and looking at the diversity of our communities, Kanaka Maoli to malihini. What would be the processes and protocols for newcomers that come to Hawai'i? We as "keiki o ka 'āina" are brought up with these values but how to we engage and transfer these values to the newcomers
    - Mehana: really important question and others have raised similar things in chat; we embrace "inclusivity" in the Aloha 'Āina foundational principles
    - Miwa: with community-based governance, what is our source of wisdom? Looking at the Burial Councils as a governance organization that does connect to sources of wisdom; power and equity is really about design; how to make community-based governments better?
  - Kaleohana: imagining the different futures where communities can stop gentrification? (cited how Mexico engages with malihini on their lands to empower the communities)
- Proposal #2 - Kevin Chang (KUA):

- Community-based natural resource management and governance jobs (mauka to makai)--in government and in community
  - We need to get some of our folks back to work and how can this create new jobs
- Q&A
  - What is the proposed timeline for this?
    - Kevin: DLNR has only recently hired to work with communities to plan fisheries (Mo'omomi, etc.); also a job position in DOCARE to be the "Ma Kai Watch Coordinator" and there is potential for this to happen beyond the fisheries, like water sheds, etc.; a lot of our young people want this and they have expectations that we have yet to meet
  - Kawika: [shared the sketch questions that were answered in the sketch form]
  - Leslie Correa: is this similar to the old CCC (Civilian Conservation Corps) that was created by the federal government?
    - Kevin: I see that they are different; it is different because it is more focused on workforce and jobs; which is different from employing everyone and getting people out there
  - Kristen: so is the idea to delegate some responsibility to communities?
    - Kevin: Hā'ena law allows families and community to partner with the government; "put out their own fires in their community"; our State is learning from this work too
  - Lisa: how should k-12 and post secondary education change if at all to prepare for this Kevin?
    - Kevin: so much for us to learn about the history of Hawai'i and how we have done this work in the past
  - Christine: what role does access to technology/internet play in providing workforce opportunities?
    - Kevin: government needs to work better with communities to gather data and inform better decisions
  - Mehana: [mentioned the Green Fee in the chat and also more funding for DLNR to do work]
  - Nālani: if we had more common knowledge of our water sources, through ahupua'a knowledge, we can raise the common knowledge in Hawai'i. When we create abundance of resources, it leads to more harmonious terms in resolutions. Not just sustainable abundance but perhaps working with the incarcerated population to grow medical marijuana. We need to look at the laws and policies now to see how they factor in.
  - Kawika: what is an aspect of this that challenges you and you'd like to ask the group for advice on?
    - Kevin: discussions on macro topics--CCC and/or funding through a Green Fee; encourage you all to go in and rip me up (good/bad) and be engaged; mahalo!
  - Mehana: [highlight comments about revenue streams, etc.]
    - Kevin: Moloka'i is talking about removing blooming algae for farming and other uses

- Kawika: [encourage participants to engage with Consider It and share comments to the questions too (“Top Pros” and “Top Cons”)]
- Proposals in the chat: “what would strengthen community governance in Hawai‘i?” (Mehana)
  - [Find ideas in the chat]
  - Noelani Kalipi: need for reciprocity; what if the community made the rules and parameters for engagement?; it’s an iterative process;
  - Mehana: community governance enhancing “traditional” governance; technology and broadband to engage; signage that links to policies, processes, etc. that are connected to the ‘āina
  - Dick: have groups physically come together once it’s safer for us all; very important to have communities work together and perhaps through teams
    - Noe Noe: we will compile everything and get it back out to the community so that the community can use it
      - Also, sharing with policy makers, decision makers, Ali‘i Trusts, and others
      - As far as we understand, we are putting in the real effort to reach out into the community
      - This is the new “cafeteria meetings”
      - Although technology has limitations, and not all of our community members have access to connect like us, this is the only way to do so safely right now
      - “Kupuna guide us every step of the way”
      - We really like what we see in the chat
      - This is a public forum and will go on the website
        - Hopefully your million dollar idea was not shared and possibly appropriated by another
        - If you do have one, maybe keep to yourself and not add to this format
      - Dreams
        - If something comes to you, come back and fill out the form to share your proposal
      - Not sure how will we get communities to work together
      - Leverage platforms like Zoom to get community together to talk with neighbors
      - “Let’s not wait for government to figure it out”; “we just need to do it ourselves”
