6:15 pm RVS Aftercare Discussion

- Proposal to offer an after school program at RVS

Committee members discussed a proposal to offer after school programming at RVS on Tuesdays, Wednesdays, and Thursdays, for six week sessions with one week off in between for make-up days as needed. Minimum of five participants per week, \$270 per child per session. Families in need of childcare five days a week are encouraged to register for Part 2 which includes a substantial state sponsored subsidy. Sign up for the RVS program will need to be facilitated and a deadline for sign up will be announced as soon as possible. Registration numbers will be required by the bus company.

6:30 pm Transportation Discussion

- Bus route recommendations to district administration

The bus company cannot send a bus up Steele Hill Rd because of the steepness of Steele Hill Rd. An option of having the Steele Hill Rd route stop at Horner Rd was discussed. The East Roxbury bus will extend to Bull Run Rd before continuing to Montpelier. A separate bus will operate in the Roxbury Village and continue to Montpelier. Both buses will carry passengers all the way to Montpelier instead of a previously proposed single bus.
