X Restrictions

Direct linking on advertising platforms such as Google ads or Microsoft Ads is not allowed, and you will not be credited. Brand name bidding is not allowed. **Google Ads of any kind are not allowed.**

We understand that social media is a powerful tool for promotion and outreach. However, to avoid brand dilution and potential conflicts with our direct marketing efforts, we require all affiliates to adhere to this policy. Violations of this guideline will result in the suspension or termination of your affiliate status and retraction of commissions. We have a zero tolerance policy if you do not follow our rules.

You may not:

- use your affiliate link in any paid media. This includes advertisements such as search engine ads, Facebook or Instagram ads, or anything similar that would compete or otherwise cannibalize Jenni Al's marketing and cause confusion for potential customers.
- bid in your pay-per-click campaigns on keywords such as jenni.ai, Jenni AI, Jenni coupons, Jenni AI discounts, www.jenni.ai, https://jenni.ai/, and/or any misspellings or similar alterations of these, be it separately or in combination with any other keywords. In order to use any Jenni AI related keywords through paid advertising you need prior approval from one of Jenni AI's affiliate managers and direct the traffic from such campaigns to your own website before redirecting it to our website.
- use "doorway pages" in such instances or overall as part of Jenni Al promotional activities is also strictly prohibited.
- transmit any so-called "interstitials," "Parasiteware," "Parasitic Marketing," "Shopping Assistance Application," "Toolbar Installations and/or Add-ons," "Shopping Wallets" or "deceptive pop-ups and/or pop-unders" to consumers from the time the consumer clicks on a qualifying link until such time as the consumer has fully exited the Jenni Al Website (i.e., no page from our site or any Jenni Al content or branding is visible on the end-user's screen). As used herein a. "Parasiteware" and "Parasitic Marketing" shall mean an application that:
 - through accidental or direct intent causes the overwriting of Affiliate and non-Affiliate Commission tracking cookies through any other means than a customer initiated click on a qualifying link on a web page or email;
 - intercepts searches to redirect traffic through an installed software, thereby causing, pop ups, Commission tracking cookies to be put in place or other Commission tracking cookies to be overwritten where a user would under normal circumstances have arrived at the same destination through the results given Internet search and directory engines (services referred here as examples include, but are not limited to, Google, MSN, Yahoo, Hotbot);
 - set Commission tracking cookies through loading of the Jenni AI site in IFrames, hidden links and automatic pop ups that open Jenni AI's website;
 - targets text on websites, other than those sites 100% owned by the application owner, for the purpose of contextual marketing; or

- removes, replaces or blocks the visibility of affiliate banners with any other banners, other than those that are on websites 100% owned by the owner of the application; or
- any other use that may be regarded as fraudulent according to common online marketing practice according to generally accepted industry specific code of conducts and guidelines (such as of IAB Europe).
