I/we hereby expressly consent to my/our child's participation in student activities. I/we acknowledge that such participation includes but is not limited to, training for, participation in, attendance at, travel to (public or private), or other involvement in any and all parts of the activity.

I/we understand that the activity involves inherent other risks of INJURY.

In consideration of the right to participate in the activity, and except to the extent there is available and collectible liability insurance providing coverage for them, I/we hereby release from any legal liability Pioneer Valley Performing Arts Charter Public School (PVPA) and its trustees, employees, faculty, staff, agents, instructors and all individuals assisting with the activity for injury or death caused by or resulting from my/our child's participation in the activity or in any way connected with my/our child's participation in the activity, whether such injury or death was caused by the alleged negligence of PVPA, another participant, or any other person or cause. This agreement will apply for each and every day I slash my child engage(s) in the activity during the period July 1, 2019 to June 30, 2020 without requiring me to sign an additional form for each day or activity.

I/we represent that I/my child am/is fit in satisfactory visit to participate in this activity. I/we authorize any person connected with the activity or PVPA to administer first aid to me/my child, as they deem necessary. I/we authorize medical and surgical care and transportation to a medical facility or hospital for treatment necessary for me/ my child's well-being, at my/our expense.

This agreement is governed by the laws of the State of Massachusetts. If any part of the agreement is determined to be unenforceable, all other parts shall be given full force and effect. The undersigned parent or guardian acknowledges that she/he is signing this agreement on behalf of a minor and that the minor shall be bound by the terms of the agreement. This agreement shall be binding on the participants assignees, subrogors, heirs, next of kin, executors and personal representatives.

SPECIFIC NOTICE AND ACKNOWLEDGEMENT OF PARTICIPATION IN
STAGECRAFT AND/OR LIGHTING STUDENT ACTIVITIES

This Notice and Acknowledgement is being to you because you have a student who is involved in student activities that include *stagecraft* and/or *lighting* work. This document is to be considered an Addendum to the Pioneer Valley Performing Arts Charter Public School's ("PVPA") *Permission and Release of Liability* document, and is incorporated therein and hereto by reference, as it fully set forth. Said *Student Activities Permission and Release of Liability* document provides for your permission and release of liability as to all student activities, as set forth therein, and includes the type of activities discussed in this Addendum. This Addendum provides for specific notice of the types of activities involved in *stagecraft* and/or *lighting*, and is not to be interpreted as a separate or in any manner required, by either the *Student Activities Permission and Release of Liability* document nor any law or regulation.

Be advised that your student and other students involved in stagecraft and/or lighting student activities will or may be engaged in the following types of activities, of which you are put on notice of and you acknowledge such, as and where indicated. Your signature also reaffirms your permission and release of liability as set forth in said PVPA's *Student Activities Permission and Release of Liability* document, and further, acknowledge your understanding that said documents scope includes and applies to but is in no way limited to the types of activities mentioned herein, including the special or inherent risk therein, if any.

- Handling of scenery
- Handling of lighting equipment and circuitry
- Use (including climbing) of ladders and scaffolding
- Use of hand tools (e.g., hammers, staples, wrenches, etc.)
- Use of power drills and screw guns
- Use of reciprocating and/or jig saws, cross cut and/or chop saws, circular saws, table saws, bandsaws
- Use of router
- Use of planer

N.B.: This list is not intended to be inclusive of all of the activities that will or may be engaged in during the *stagecraft* and/or *lighting* student activities, but rather, is a representative sample.
