COACH REPORT: Coach Molly

- Things are going well. Eight athletes attended the first 2 K this weekend.
 Hopefully, that number will improve. Approximately 15 athletes attended the 3 by 2,500 yesterday.
- There have also been additional participants who may join the team.
- The middle school attendance has been good.
- U.S. Rowing's membership dues increased from \$400 to \$500.
- We have to show we are insured by our school district so we do not have to buy outside insurance.
- The Midwest Scholastic Association also has dues of \$161, based on last year's team numbers.
- The State Rowing Association of Michigan's dues are usually about \$3 per rower.
 That will come into play at the May 20, 2023 state regatta.
- Coach Fiske asks for the PowerPoint to be updated.
- The Hungry Eagle Erg regatta is on March 4, 2023.
- There is a coach meeting this weekend.
- The guidelines for practice carpooling need to be determined. We would like to have consistency regarding with whom team members ride. Drivers need to have better communication from team members if they will not be attending practice.
 The expectations could be added to the carpooling authorization form.
- For the March 1, 2023 meeting, we should have stations for carpooling, U.S. Rowing membership, Big Teams, uniforms, Give Us a 10, and GroupMe.

- -Using the current estimates, we would be at \$6,700 less after the season. Traditionally, we try to stay above \$10,000.
- -For the coming seasons, we need to grow the team and fundraise to increase revenue.
