#### III. SBAC Participation:

- SBAC Participation is required by state law. Students who do not test negatively impact our participation rates with the [NSPE \(Star Rating\)](#).
- Any group or subgroup that does not meet 95% participation on each assessment will be flagged. In the first year of flags, a school will receive a “participation warning” but will have no points deducted (22-23). A second consecutive year of flags (23-24) will result in a school receiving a “participation penalty” and points will be deducted from the Academic Achievement indicator.
- How do we address a post covid culture of parents not sending their child to school

Participation on State Assessments

At least 95% of all students and 95% of students in each subgroup must participate in the state Math and ELA assessments. Any group or subgroup that does not meet 95% participation on each assessment will be flagged. In the first year of flags, a school will receive a “participation warning” but will have no points deducted. A second consecutive year of flags will result in a school receiving a “participation penalty” and points will be deducted from the Academic Achievement Indicator, based upon the number of flags. Subsequent consecutive years of flags will result in points deducted. Note that the same subgroups do not need to be flagged each year to receive warnings/penalties. Only Math and ELA assessments impact participation warnings/penalties.
