This promotion is a skill-based competition and does not constitute a lottery, sweepstakes, or game of chance. The winner will be determined through a judged creative entry process and community vote, as described below.

1. Sponsor

The Sponsor of this Competition is Acer Inc., owner of the Predator Gaming brand. References to "the Sponsor" throughout these Terms & Conditions refer to Acer Inc.

2. Eligibility

The Predator Gaming Helios Neo 16S AI Custom Forza 6 (the "Competition") is only open to individuals who are 18 years of age or older as of the date of entry and who submit a valid entry.

The Competition is open worldwide except where prohibited by law. The following countries are ineligible due to restrictive laws regarding contests, lotteries, or prize promotions that may require government approval, prohibit such activities, or impose strict tax and compliance regulations: North Korea, Iran, Sudan, Syria, the Crimea Region of Ukraine, China, Russia, Hong Kong, South Korea, Portugal, Italy, Austria, Greece, France, Japan, Spain, Czech Republic, and Mexico.

4. Entry Period

The Competition begins on 1 September 2026 at 12:00AM BST and ends on 15 September 2026 at 11:59PM BST (the "Entry Period"). Entries submitted before or after the Entry Period will not be eligible.

5. How to Enter

To enter the Competition, participants must comment their dream car.

Submit your response in the comments and pass on any verification requirements (email or fraud score) set by the Sponsor.

The entry must fulfil all requirements of the Competition, as specified, to be eligible to win a prize. Entries that are incomplete, offensive, defamatory, or do not adhere to the rules or specifications of the Competition may be disqualified at the sole discretion of the Sponsor. You must provide the information requested. Only one (1) entry per person is permitted across all entry methods. Winner Announcement

Following successful contact with the winner as determined by the community vote, the winner will be published on the official Predator Gaming Instagram account (@PredatorGaming) on 16 September 2026 at 12:00PM BST. The Sponsor reserves the right to change the date of the winner announcement if the winner has not claimed their prize within the allocated period as detailed in Section 8.

7. Prizes

The winner(s) of the Competition (the "Winner") will receive the following prize:

The Sponsor reserves the right, in its sole discretion, to cancel, terminate, modify, or suspend the Competition should a virus, bug, non-authorised human intervention, fraud, or other cause beyond the Sponsor's control corrupt or affect the administration, security, fairness, or proper conduct of the Competition. In such cases, the Sponsor may determine a winner from eligible entries received before and/ or after the action taken by the Sponsor, if appropriate. The Sponsor reserves the right, at its sole discretion, to disqualify any individual who tampers or attempts to tamper with the entry process or the operation of the Competition or website, or who

violates these Terms & Conditions. The Sponsor has the right, in its sole discretion, to maintain the integrity of the Competition and to void entries for any reason, including, but not limited to: multiple entries from the same user from different IP addresses; multiple entries from the same person in excess of that allowed by the Competition rules; or the use of bots, macros, scripts, or other technical means for entering. If a solution cannot be found to restore the integrity of the Competition, the Sponsor reserves the right to determine a winner from among all eligible entries received before the Competition was required to be cancelled, changed, or suspended, using the judging criteria outlined in Section 6. If you attempt to compromise the integrity or the legitimate operation of this Competition by hacking, cheating, or committing fraud in any way, the Sponsor may seek damages from you to the fullest extent permitted by law and may ban you from participating in any future Predator Gaming or Acer promotions.

12. Limitation of Liability
