## **JUSTICE FOR LGBTQ+ VETERANS**

# Farrell v. Department of Defense

### **OVERVIEW**

On August 8, 2023, a group of LGBTQ+ veterans discharged under the discriminatory "Don't Ask, Don't Tell" ("DADT") and similar earlier policies filed a class action lawsuit against the U.S. Department of Defense seeking to end ongoing discrimination perpetuated by their discharge papers. The lawsuit, filed in the U.S. District Court for the Northern District of California, seeks the removal of narratives and separation codes that disclose the veteran's sexual orientation and, when needed, seeks upgraded discharge statuses for tens of thousands of veterans discharged under DADT and its predecessor policies. The Plaintiffs are Sherrill Farrell, James Gonzales, Jules Sohn, Hayden Powell, and Lilly Steffanides. The Plaintiffs are represented by the Impact Fund, Legal Aid at Work, and King & Spalding LLP.
