Run Order: Trials will be run concurrently.

Move Ups & Downs: In accordance with NASDA rules, move ups and downs are permitted for teams who complete a title at the event. All changes must be made before the class in which the team wishes to compete begins.

Awards & Fun: Awards will be handed out at the conclusion of the trial. Ribbons are awarded for Qualifying score and High in Trial. New title rosettes will be awarded. Please contact the Trial Secretary if you will be earning a title above level two.

Bitches In Season: Bitches in season are eligible to compete. They must notify the Trial Secretary via email in advance of the trial. Bitches in season will run at the end of the event and must wear appropriate britches.

Venue/Parking:

Exhibitors will be crating in their vehicles, **Mountain Home Dog Sports** reserves the right to remove any individual for any reason from the premises. No refunds will be issued. Please pack food and water for you and your dog. No RV parking. Absolutely No alcohol or drug use allowed during the trials. If suspected, you will be asked to leave immediately with no refund and your entries will not be accepted at any future MHDS event.

- Pre-entry deadline is: 11:59 pm on July 3, 2026. Entry fees for entries made after the deadline increase by \$5/trial
- Cancellations must be made via email to the Trial Secretary
- Refunds will be mailed 7 days after the event
- No refund for cancellations after the closing date
- No refunds will be made for cancellations after the closing date or entries which are absent, disqualified, excused, or barred from competition by decision of the Trial Committee
- Exhibitors are responsible for complete, accurate and legible information on their entry forms
- It is expressly understood that exhibitors alone are responsible for behavior of their dogs, children and/or guests. Any exhibitor whose dogs, children and/or guests repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Trial Committee, be asked to leave the trial site. In such case, no refund on any entry will be made
- No entry fee will be refunded if the trial cannot open or be completed by reasons of riots, civil disturbances, fire, weather, acts of God, public emergency, an act of a public enemy, or any cause beyond the control of Mountain Home Dog Sports
- All dogs must be on leash at all times except when competing
- Exhibitors are responsible for being in the staging area when it is their turn to run
- Please be courteous and pick up after your dog
