# Terms of Use for Mosaic AI – AI App Builder

Last updated: August 30, 2025

These Terms of Use ("Terms") govern your access to and use of **Mosaic AI – AI App Builder** ("App", "Service"), developed by **Andrei Vychau** ("Andrei Vychau", "we", "us", "our").

By downloading, accessing, or using the App, you agree to be bound by these Terms. If you do not agree, please do not use the App.

# 1) Acceptance of Terms

By using the App you (a) confirm you have read and understood these Terms and our Privacy Policy; (b) are of legal age to enter into a binding agreement (or have consent from a legal guardian); and (c) accept these Terms.

### 2) Service Description; Generative AI

The App provides tools to **build Al-powered applications** and workflows using natural language, prompts, and other inputs. The Service may generate code, designs, texts, or other outputs ("Al Outputs") using artificial intelligence and large language models. **Al disclaimer:** Al Outputs can be **incorrect, incomplete, biased, outdated, or insecure**. You are solely responsible for independently reviewing, testing, and validating Al Outputs (including security, IP clearance, and compliance) before using or distributing them.

# 3) Permitted Use

You agree to use the App **only for lawful purposes** and in compliance with all applicable laws and these Terms. You **shall not**:

- Access the Service via automated means (bots, scrapers) except through officially provided APIs (if any).
- Attempt unauthorized access, probe or impair security, or disrupt Service operation.
- Upload malicious code, spam, or content that infringes IP, privacy, or other rights.
- Use the Service to generate, host, or distribute illegal, harmful, deceptive, or discriminatory content.

- Benchmark, reverse engineer, or reproduce Service features to build a competing product.
- Violate export control, sanctions, or platform policies (Apple/Google).

# 4) Accounts and Security

You may need an account to use certain features. Provide accurate information and keep credentials confidential. You are responsible for all activity under your account and must promptly notify us of any unauthorized use.

# 5) Intellectual Property

- Our IP. The App, its software, design, features, and trademarks are owned by Andrei
  Vychau and protected by IP laws. Except as expressly permitted, you may not copy,
  modify, or distribute our IP.
- Your Content. You retain ownership of prompts, assets, data, and materials you upload ("User Content").
- License to Operate the Service. You grant us a worldwide, royalty-free, non-exclusive license to use, host, reproduce, process, and display your User Content solely to provide, maintain, safeguard, and improve the Service and to generate Al Outputs for you.
- AI Outputs. As between you and us, you may use AI Outputs generated for your
  account subject to these Terms and applicable law. We make no warranty that AI
  Outputs are exclusive or free of third-party rights (including open-source obligations).
  You are solely responsible for clearance, compliance, and any attributions/licenses
  required for downstream use.

### 6) Open-Source and Third-Party Materials

Al Outputs or project templates may incorporate **open-source** or third-party components subject to their own licenses. You are responsible for reviewing and complying with those licenses (e.g., attribution, copyleft). The Service may link to third-party sites; we are not responsible for third-party services or content.

### 7) Subscription, Payments, and Renewals

Certain features require a **paid subscription** or one-time purchases. By subscribing, you agree to pay the displayed fees and applicable taxes. **All payments are non-refundable** 

except where required by law or expressly stated otherwise in the App or the applicable app store.

- **Auto-renewal:** Subscriptions renew automatically unless canceled before the renewal date.

We may add, modify, or discontinue features at any time. We may release updates, fixes, or patches that you may be required to install to continue using the App. Service uptime is not guaranteed.

We may suspend or terminate your access (with or without notice) if you violate these Terms, fail to pay fees, or if we discontinue the Service. Upon termination, your right to use the Service ceases; we may delete related data per our retention policies and applicable law.

# 17) Governing Law; Venue

These Terms are governed by the laws of the jurisdiction in which we operate, without regard to conflict of law principles. Where permitted by law, you agree to the exclusive jurisdiction and venue of competent courts in that jurisdiction for any dispute not subject to arbitration/mandatory local rights.

# 18) Dispute Resolution (Optional Arbitration)

Where allowed by law, disputes may be resolved through **binding individual arbitration** instead of court, and **class actions are waived**. If mandatory local consumer rights prohibit arbitration or class waivers, this section does not apply.

# 19) Severability; Waiver; Entire Agreement

If any provision is found unenforceable, it will be modified to the minimum extent necessary; the remainder remains in effect. Our failure to enforce a provision is not a waiver. These Terms, together with the Privacy Policy, constitute the **entire agreement** between you and us regarding the Service.
