• Legal Expertise (if applicable):

Describe your background in law, particularly those areas pertinent to blockchain, digital security and procurement frameworks. Include any specific legal qualifications, roles in legal departments or firms, and involvement in relevant legal cases or advisory capacities.

Procurement Expertise (if applicable):
