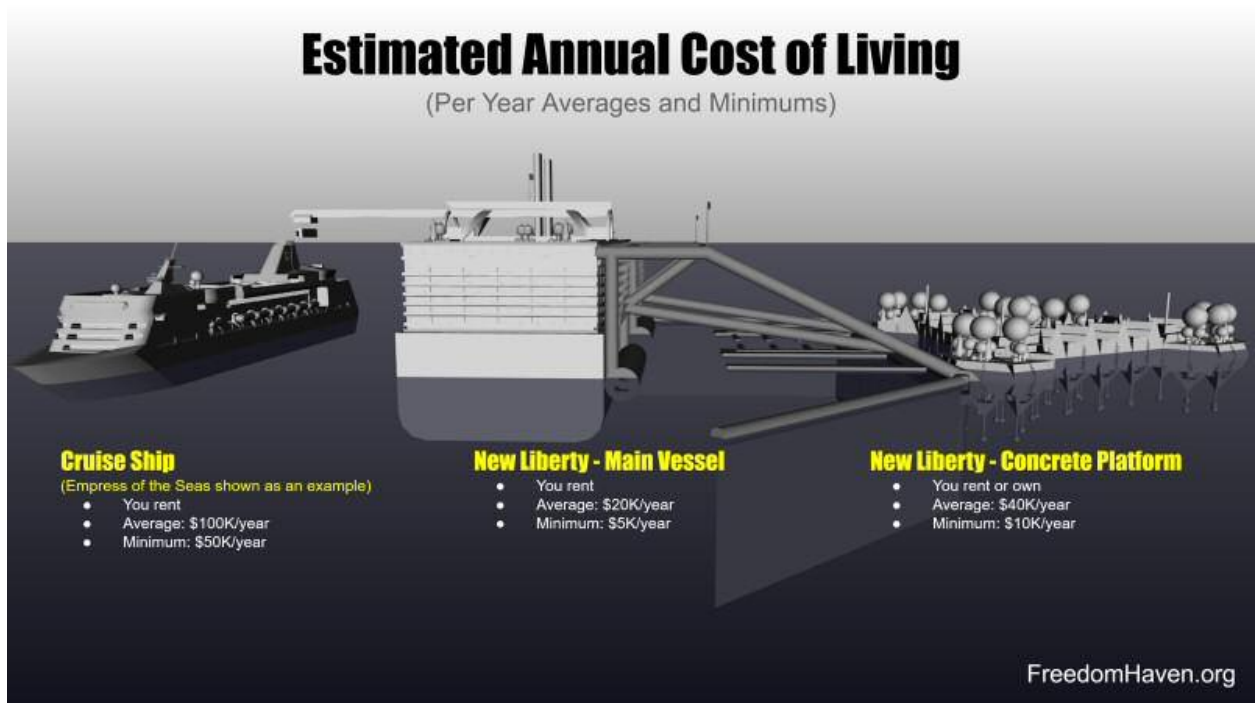
From El Stone: **“What happens if the resident doesn't pay rent (as Dan Kidd (Cats) did numerous times to his landlords, for tens of thousands of dollars worth of defaulted debts)?”**

Freedom Haven is a country made up of multiple provinces who comply with Freedom Haven's constitution. On the water, each vessel is its own province, and they will decide how to best implement the Constitution. Property owners always get to choose who is on their property and for how long, and visitors & renters can choose which offers of housing to agree to (and for how much) based on mutual trust. No one will be forced to do business with those they don't want to.

I don't know [Dan Kidd](#)'s details, but it sounds like he may have used the current corruption in US laws to grant himself “squatter's rights”. In Freedom Haven he might have trouble finding people who trust him enough to rent to him.

Theft (which includes trespassing) is illegal in Freedom Haven. There are no “squatter's rights” in Freedom Haven. Contracts will record what consenting adults agree to, and courts will uphold those contracts.

The province of New Liberty (the main large vessel shown below) won't let anyone onboard without proof that they have an open-ended two-way ticket to take them back to where they came from (or another destination) when they leave. New Liberty will have no long-term prisons - anyone who kills, kidnaps (et al.) or steals (et al.) and doesn't fix what they broke, will be kicked out.

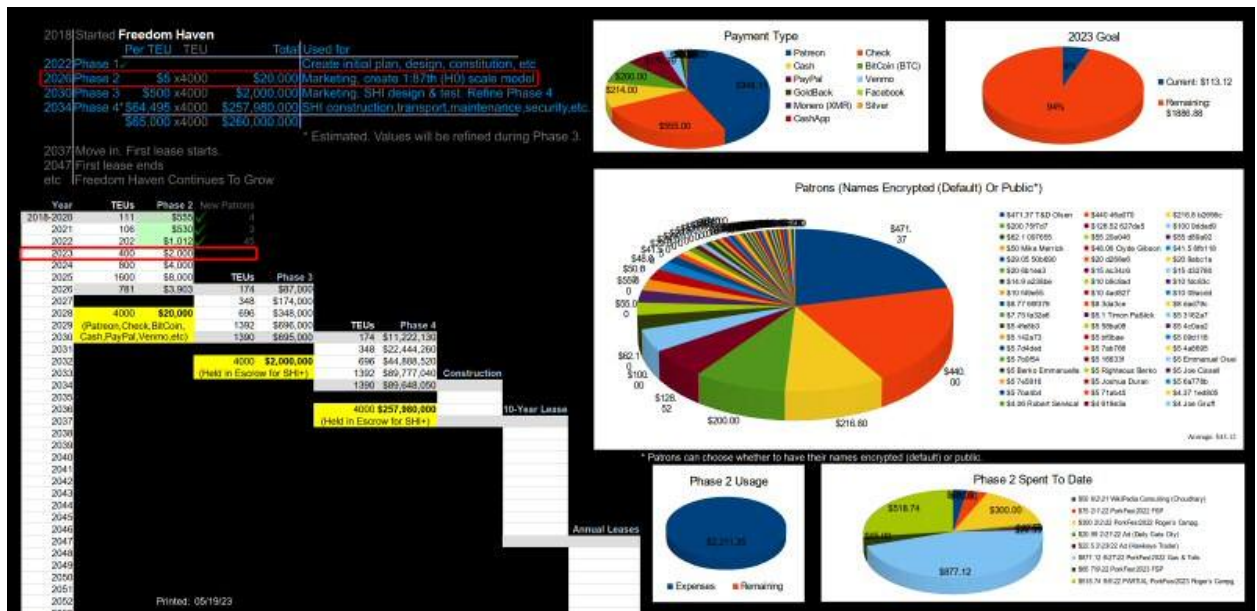


New Liberty will have 10-year leases on its 4,000 cabins, which are paid for in advance by investors. [Renters will pay monthly at a higher price](#), and the lease owners will offer rates and contracts (which include late-payment grace periods, if any) and renters decide which investors they want to rent from.

The situation, as I understand it, with Dan Kidd would not occur in New Liberty unless the landlords allow it to.

Monthly Freedom Haven constitution section mini-overview

The [Preamble](#) of Freedom Haven Constitution:

We the individual People, in order to secure the [human right to defend](#) ourselves, [to limit the scope of Government](#), and to secure the Blessings of [Liberty](#) to ourselves and our Posterity, so that we can have the chance to learn, grow, and work towards achieving our greatest individual divine potentials (so that through our efforts, and without [compulsory means](#), prosperity may flow unto us forever and ever), do ordain and establish this Constitution for the [Provinces](#) that form the Country of Freedom Haven.

DEFENSIVE FORCE (or Self-Defense)

- DEFENSIVE FORCE** (or **Self-Defense**): is using **Force** only to **defend** your **Life** from **Murder**, your **Property** from **theft/invasion/trespassing/arson/vandalism/rape/etc.**, or your **Freedom** from **kidnapping/rape/etc.**
 - Force** is only **Defensive-force** as long as the threat to **Life**, **Freedom**, and/or **Property** remains active. Justice, retribution, and/or vengeance are not **defensive-force** and are not justifications for using **Force**.
 - Only the reasonably known least amount of **force** against an attacker is justified for **self-defense**.
