PROCEDURE FOR PUBLIC FORUM

Policy BDDH

No individual will be allowed to speak more than once during this period. If a decision is expected from the Board, a request needs to be made for the item to be placed on an agenda. However, statements regarding issues or concerns about individual students, staff members, or legal matters are not allowed during open sessions. A request may be made to appear before the Board in closed session.
