General Formatting Requirements

Manuscripts must be prepared using Microsoft Word format (.docx). Use A4 paper size, Times New Roman, 11-point font for the main text, 1.5 line spacing, justified alignment, and 2.54 cm margins on all sides. The abstract must use single line spacing. The manuscript must be between 6,000 and 8,000 words, including the main text, tables, figures, and excluding references and appendices.

- Use a single-column format throughout the manuscript.
- Do not use headers, footers, decorative borders, or institutional letterheads unless instructed by the conference secretariat.
- Use clear section headings. Main headings should be 12 pt, bold. Subsection headings should be 11 pt, bold.
- All in-text citations and references must follow the American Psychological Association (APA) 7th edition style.
- Tables and figures must be cited in the main text before they appear.
- Authors are responsible for ensuring originality, language quality, accuracy of citations, and ethical use of data.

Abstract

Subsection Heading
